(2) SOLORZANO RULING

RULING #41

IN THE MATTER OF: MARTIN SOLORZANO

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER MARTIN SOLORZANO ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING # 239, DATED NOVEMBER 19, 2011, SUSPENDING MR. SOLORZANO FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1547 (FAILURE TO APPEAR), IS HEREBY SET ASIDE AND MR. SOLORZANO IS NOW ELIGIBLE FOR RELICENSURE.

The foregoing ruling was issued after owner Martin Solorzano satisfied his outstanding debt to Equine Sports Medicine.

(3) GONZALEZ HEARING (CASE #12LA0055)

Valet Jesse Gonzalez appeared before the Board of Stewards for a formal hearing to address the complaint of alleged violation of California Horse Racing Board Rule #1874 (Disorderly Conduct) and #1489 (g) (Grounds for Denial or Refusal of Licensure).

Present at the hearing were the Board of Stewards Albert Christiansen, James Dreyer and George Slender, Senior Supervising Investigator Tom Blake, Sergeant Keith Hicks representing Security, respondent Jesse Gonzalez, Union Representative Jeffery Froehlich and Certified Court Reporter Barbara Weinstein. Subject waived his right to representation.

Mr. Gonzalez testified that he had two or three drinks prior to coming to work. He also admitted to having a long standing problem with alcohol. He stated he is currently enrolled in an Alcoholics Anonymous program and has been for the past three weeks. The Stewards advised Mr. Gonzalez that they will take this matter under submission and will render a decision tomorrow.

(2) VALET GONZALEZ RULINGRULING #42

VALET JESSE GONZALEZ IS SUSPENDED FIFTEEN (15) DAYS (MARCH 4, 2012 THROUGH MARCH 18, 2012) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT - INTOXICATION) AND CALIFORNIA HORSE RACING BOARD RULE #1489 (G) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE).

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF SUBJECT ARE SUSPENDED, AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

FURTHERMORE, AS A CONDITION OF REINSTATEMENT JESSE GONZALEZ SHALL SHOW PROOF OF CONTINUING PARTICIPATION IN AA, AND SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD.

The above ruling was issued following due deliberation concerning testimony and documents offered in his hearing. Mr. Gonzalez once again stated that he is a different person since attending Alcoholics Anonymous classes.

(3) GONZALEZ RULINGRULING #43

TRAINER FELIX GONZALEZ IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION) ON SUNDAY, MARCH 4, 2012.

The foregoing ruling was issued after speaking with trainer Gonzalez telephonically. Subject admitted he erred in not having the horse on the grounds.

(4) SEVENTH RACE – INQUIRY - ACCIDENT

The Stewards posted the Inquiry sign in order to evaluate a spill involving #3 “Single In May” (jockey Dionicio Navarro – trainer Jim Hanson) approaching the 1/8th pole. After reviewing the racing tapes it was decided to make no change in the order of finish.

The tapes reflect that “Single In May” was racing in the clear when she fractured her left front leg and went down. The mare was humanely euthanized on the racetrack and the rider was transported to the hospital after complaining of possible rib and back problems.
