Report of the Board of Stewards for the week of October 11, 2011 through October 16, 2011.

TUESDAY

10/11/2011

(1) **DUTY STEWARD**

Albert Christiansen will be present for morning duties and shall author the week's minutes.

(2) **CAL-BRED REPORT**

Two races were offered CAL-BRED in the book, neither filled. The fourth race for three year olds and upward, claiming price \$2,500, going 350 yards, had no entries. Sub 2 for two year olds, claiming price \$8,000, going 350 yards, attracted one entry.

(3) **THE DRAW**

Ten races were drawn for Friday's program. Five Thoroughbred and five Quarter Horse races make up the card.

WEDNESDAY

10/12/2011

(1) **SCRATCHES**

One scratch and one equipment addition completed scratch time at 9:00 a.m.

(2) **CAL-BRED REPORT**

Three races were offered CAL-BRED in the condition book, none of which filled. The first race for maidens, two years old, claiming price \$2,500, going 330 yards, had two entries. The second race for maidens, fillies two years old, going 300 yards, attracted two entries. The fourth race for three year olds which have not won a race in 2011, going 350 yards, had one entry.

(3) **THE DRAW**

Ten races were drawn for Saturday's program. One Thoroughbred and nine Quarter Horse races complete the card. Four of the Quarter Horse races are "Los Alamitos Super Derby Trials."

(1) **SCRATCHES**

Two flipping halter additions completed scratch time at 9:00 a.m.

(2) CAL-BRED REPORT

There was no CAL-BRED race offered today. The only race in the book was for the "Golden State Million Futurity Trials."

(3) THE DRAW

Ten races were drawn for Sunday's program. All races were trials for the "Golden State Million Futurity."

FRIDAY

(1) SCRATCHES

Two rider changes completed scratch time at 9:00 a.m.

(2) SECOND RACE – INQUIRY - DISQUALIFICATION

After the finish of the second race (Quarter Horse – 300 yards) the Stewards posted the Inquiry sign to review two incidents at the start. The first incident involved the second place finisher #8 "Feature Mr Willie" (jockey Carlos Huerta) and the fourth place horse #9 "Tac It To Heart" (jockey Cesar De Alba). After talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to make no change. Replays show, at the break, #8 brush #9, who over reacts, contributing to her problem. The second incident involved the third place finisher #7 "Point Reyes" (jockey Alex Bautista) and all of the horses inside of him. Replays show #7, shortly after the start, drift down to the five hole. The horses to the inside of him lose all chance in the race.

(1) JOCKEY REVIEWS DISQUALIFICATION

Jockey Alex Bautista appeared to review last night's second race disqualification of his mount. After a thorough review the Stewards were of the opinion the rider made an acceptable effort to correct his mount.

(2) SUAREZ RULINGRULING #219

JOCKEY GUILLERMO SUAREZ WHO RODE "SHORT HAWK" IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, OCTOBER 9, 2011, IS SUSPENDED THREE (3) RACING DAYS (OCTOBER 21ST, 22ND AND 23RD, 2011) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM THIRD TO FOURTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

This ruling was issued after jockey Suarez reviewed last Sunday's fourth race disqualification of his mount. Suarez admitted he was late to correct his lugging in mount.

(3) SEVENTH RACE – INQUIRY – DOUBLE DISQUALIFICATION

After the finish of the seventh race (Quarter Horse – 400 yards – second division Los Alamitos Super Derby trials) the Stewards posted the Inquiry sign to review an incident at the start. Involved were the second place finisher #4 "Walkin Bac" (jockey Juan Andrade), the fourth place filly #7 "Kips Kitten" (jockey Eduardo Nicasio), the seventh place finisher #6 "No Bad Habits" (jockey Cesar De Alba) and the eighth place horse #5 "Adashin First Dash" (jockey Adrian Loza). After talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to disqualify both #4 and #7 for interference to both #5 and #6 at the start. Replays show #7 break in and #4 break out to the extent the latter pair each lost the opportunity at better placings.

(1) RIDER REVIEWS RACE

Jockey Eduardo Nicasio accompanied by agent/interpreter Saul Servin, appeared to review last night's seventh race disqualification of his mount. The horse stumbled at the break and the Stewards concluded the rider made a reasonable effort to correct his mount.

(2) ANDRADE RULING

RULING #220

JOCKEY JUAN P. ANDRADE WHO RODE "WALKIN BAC" IN THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, OCTOBER 15, 2011, IS SUSPENDED THREE (3) RACING DAYS (OCTOBER 23RD, 28TH, AND 29TH, 2011) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM SECOND TO SEVENTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

This ruling was issued after jockey Saul Ramirez, Jr. appeared and represented Juan Andrade. Andrade's mount was disqualified in last night's seventh race. Mr. Andrade was late to correct his mount in a weak effort.
