(2) AMEZCUA RULINGRULING #134

TRAINER GERARDO AMEZCUA IS FINED TWO HUNDRED DOLLARS (\$200.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1690.1 (TOE GRABS PROHIBITED - OVER FOUR MILLIMETERS) ON JULY 3, 2011.

The preceding ruling was issued after subject appeared before the Board of Stewards to give reason for his entry to be improperly shod in the fifth race on July 3, 2011. His excuse was that the horse was shipped in and he neglected to check his shoes.

(3) LATE DECLARATION - REFUND

A refund was ordered in the third race when #8 "Johnny Bonita" (Trainer Kenny Nettles – jockey Gary Boag) when Track Veterinarian Tom Hackathorn reported that the gelding was unsound. Declared by the Stewards – Refund: \$7,619.00.

(2) MURRIETA RULINGRULING #135

OWNER JOAQUIN MURRIETA, HAVING FAILED TO ABIDE BY THE TERMS OF A FINANCIAL AGREEMENT WITH EQUINE SPORTS MEDICINE, IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY).

The foregoing ruling was issued after Mr. Murrieta failed to abide by his financial agreement dated July 1, 2011 in the amount of \$2,040.68 to Equine Sports Medicine.

(3) AMARO RULINGRULING #136

GROOM ROSEMARY AMARO IS SUSPENDED TWENTY-FIVE (25) DAYS (JULY 12, 2011 THROUGH AUGUST 5, 2011) AND PLACED ON PROBATION THROUGH DECEMBER 18, 2011, FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT - INTOXICATION).

The above ruling was issued when groom Rosemary L. Amaro was afforded a hearing. Ms. Amaro was cited for being intoxicated and creating a disturbance in the grandstand. Police was summoned and she was subsequently incarcerated.

(4) LATE DECLARATION - REFUND

A refund was ordered in the third race as Track Veterinarian Tom Hackathorn reported that jockey Daniel Sandoval thought his mount #3 "Mi Marino" (Tr. R. Gomez) was unsafe to ride. Track Veterinarian Hackathorn thought the horse was sound to ride. Declared by the Stewards. Refund: \$8,027.00.

(2) SECOND RACE – INQUIRY - DISQUALIFICATION

The Stewards immediately posted the Inquiry sign following the running of the second race (Quarter Horse – 300 yards) to review an incident at the start which involved #1 "Rights White" (jockey Santiago Mendez – 4th) and #2 "Lass Toll" (jockey Rodrigo Aceves – 7th).

After speaking with the riders involved and reviewing the tape replays, the Stewards unanimously agreed to disqualify #1 from fourth to seventh position. Replays reflect #1 swerving out sharply at the start severely impeding #2, costing the latter an opportunity of better placement.

(3) STEWARDS' LIST

Following the running of the fourth race #3 "Louie Prima" (trainer J. Flores – jockey J. Andrade) was eased up shortly before the finish. Jockey Andrade was questioned by the Stewards the reason for easing up the horse. His reason was that the horse was having a breathing problem. The horse was sent to the Receiving Barn to State Veterinarian Gary Beck for examination. Later Dr. Beck reported his examination revealed nothing. The horse was placed on the Stewards' List and must requalify before starting again.
