Report of the Board of Stewards for the week of April 19, 2011 through April 23, 2011.

**TUESDAY**

04/19/2011

(1) DUTY STEWARD

Randy Winick will be on duty for this recording period to transcribe the week's minutes and attend to morning office matters.

(2) ENTRIES AND DRAW

Friday's program was drawn at 1:30 p.m. with the ten races comprised of seven Quarter Horse and three Thoroughbred contests.

**WEDNESDAY**

04/20/2011

(1) SCRATCHES

Scratches for Friday were taken at 9:00 a.m. and resulted in one declaration and one rider change.

(2) ENTRIES AND DRAW

Ten races were drawn at 12:15 p.m. for Saturday's program which will be split between seven Quarter Horse and three Thoroughbred events.

**THURSDAY**

04/21/2011

(1) SCRATCHES

The 9:00 a.m. scratch deadline yielded only one rider adjustment.

(2) ENTRIES AND DRAW

There will be no entries today for Easter Sunday, as Los Alamitos will be dark on this day.

**FRIDAY**

04/22/2011

(1) SCRATCHES

There were no scratches this morning due to there being no racing on Easter Sunday.

(2) CAL-BRED REPORT

The fourth race in the condition book for California-bred maidens, claiming price \$2,500 at a distance of 330 yards, was called off with no entries.

(3) STEWARD ABSENT

Steward Randy Winick was ill this evening. Safety Steward Albert Christiansen filled in for the evening.

(4) ARRIAGA RULINGRULING #64

JOCKEY GREGORIO ARRIAGA, WHO RODE "ALFA Y OMEGA" IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, APRIL 17, 2011, IS SUSPENDED THREE (3) RACING DAYS (APRIL 29TH, 30TH AND MAY 1ST, 2011) FOR FAILURE TO MAINTAIN A STRAIGHT COURSE SHORTLY AFTER THE START CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

This ruling was issued after jockey Arriaga appeared to review Sunday's second race with the Stewards. The rider was slow to correct a lugging in horse and made the situation worse by whipping right handed.

(5) JOCKEY REVIEWS RACE

Jockey Oscar Peinado appeared to review last Saturday's second race with the Stewards. The rider was cautioned to make a better effort to maintain a straight course.

(6) FINANCIAL COMPLAINT

An informal hearing was conducted to address a complaint against trainer Cash Robertson. Dr. Andrew Berk filed the complaint alleging a debt of \$6,766.51. The trainer admitted the debt. After testimony from both sides a financial agreement was agreed upon and signed by both participants. The agreement was for \$1,000 today, paid in cash, and starting May 1, 2011, \$1,500 a month until the debt is paid.

(7) SIXTH RACE – TRAINER OBJECTION – NO CHANGE

After the finish of the sixth race the Stewards posted the Objection sign at the request of trainer Paul Jones. Jones ran the last place horse #1 "Fountainbleu" (jockey Ramon Sanchez) and alleged interference by the fourth place finisher #4 "Our Kinda Magic" (jockey Juan Andrade) at the start. After talking with the riders involved and reviewing the replays the Stewards unanimously agreed to make no change in the order of finish. Replays show #2 break in at the start, bump #1, who broke slow, however, the incident did not cost #1 a better placing as he was beaten a considerable distance for next to last.

(1) CAL-BRED REPORT

The first race in the book, for California-bred two year old maidens with a claiming price of \$8,000 at a distance of 300 yards, failed to attract a single entry and was therefore called off.

(2) FILM REVIEW

Jockeys Juan Andrade and Cesar De Alba were both in to review the sixth and seventh races, respectively, from Friday night concerning similar incidents. Both riders were in the #2 post position and both of their mounts broke inward into the horses in the #1 stall. Jockeys De Alba and Andrade were both given a reprieve as that they did make an attempt to pull off but were counseled to react just a bit quicker in the future. Cesar and Juan were both agreeable and understanding of the assessment and said that they would do a better job in future races.

(3) RAMIREZ RULINGRULING #65

JOCKEY ABEL G. RAMIREZ, WHO RODE "MILLY MATIC" IN THE TENTH RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, APRIL 22, 2011, IS SUSPENDED THREE (3) RACING DAYS (MAY 6TH, MAY 7TH AND 8TH, 2011) FOR FAILURE TO MAINTAIN A STRAIGHT COURSE SHORTLY AFTER THE START CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was given to jockey Abel Ramirez for allowing his horse to drift into the horse immediately to his outside and knock him off stride without making any effort to stop this contact. Mr. Ramirez stated that he did the best he could and that also his mount may have shied away from the horse to his inside. None of this seemed plausible to this Board of Stewards, and jockey Ramirez was told that he must show us more effort in the future. Abel left somewhat unhappy.
