TUESDAY

03/15/2011

(1) DUTY STEWARD

George Slender will be present for morning duties and will record the minutes during this reporting period.

(2) CAL-BRED REPORT

Two races were offered for Cal-Breds on this date. The sixth race in the book failed to fill with two Cal-Breds. The seventh race was called off with one entry.

(3) THE DRAW

Two Thoroughbred and eight Quarter Horse races were carded for Friday's racing program. The draw was completed at 2:30 p.m.

WEDNESDAY

(1) SCRATCHES

Friday's scratches were conducted promptly at 9:00 a.m. without noteworthy incident.

(2) CAL-BRED REPORT

Two races were offered Cal-Bred in the condition book but neither filled. The second race in the book failed to fill with one entry. The other was called off with no entries.

(3) MORALES RULINGRULING #49

JOCKEY WILBERTH MORALES WHO RODE "FLS FLYIN TIME AGAIN" IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, MARCH 13, 2011, IS SUSPENDED THREE (3) RACING DAYS (MARCH 25TH, 26TH AND 27TH, 2011) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM THIRD TO SEVENTH. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was issued after jockey Morales reviewed the fourth race on Sunday, March 13, 2011 with the Stewards. The Stewards are of the opinion the rider could have made a better effort in correcting his mount.

(4) SEVENTH RACE – LATE DECLARATION

A refund was ordered in the seventh race when #4 "Frosty Younger" (Tr. S. Willoughby – jockey A. Alberto) became fractious in the starting gate and injured himself per Track Veterinarian Dr. Tom Hackathorn. Refund: \$16,864.00.

(2) JOCKEY GUILD COMPLAINT

Safety Steward James Dreyer responded to a Jockey Guild complaint concerning the jockey's physical examinations. At issue was the delay of the examination to be held in February but due to the fact the doctor was snowed in at Big Bear he could not be present to conduct the examinations. Safety Steward Dreyer contacted Jockey's Guild Representative Darrell Haire to discuss the complaint. The physicals were given on Friday, March 18, 2011 at Los Alamitos.

(3) GARCIA RULINGRULING #50

JOCKEY EDDIE GARCIA IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT) ON FRIDAY, MARCH 18, 2011.

The foregoing ruling was issued after jockey Garcia failed to appear to fulfill his riding engagements in last night's second and third races.

(4) SECOND RACE – INQUIRY – NO CHANGE

The Stewards posted the Inquiry sign following the running of the second race to evaluate an incident at the start, which involved #2 "Kingman Chris" (4th – jockey A. Alberto) and #3 "Lord Azoom" (6th – jockey C. De Alba). Tapes reflect #2 does break out at the start bumping into #3, but "Kingman Chris" caused his own problem by breaking slowly. After speaking with the riders involved and reviewing the films, the Stewards voted to make no change in the original order of finish.

(5) TENTH RACE – INQUIRY - ACCIDENT

The Inquiry sign was immediately posted by the Stewards following the tenth race to review an incident at the start which involved #3 "CoolnCollected" (Tr. J. Flores – jockey J. Andrade) who stumbled badly at the start, unseating his rider. No injury occurred to the rider or horse.
