Report of the Board of Stewards for the first week of racing in the year 2011 (December 29, 2010 through January 2, 2011). There are two racing days this week.

WEDNESDAY

12/29/2010 (1) DUTY STEWARD

Albert Christiansen will be present for entries and morning duties and shall compose the week's minutes.

(2) ENTRIES

Ten races were drawn for Saturday's opening day program. Four Thoroughbred and six Quarter Horse races make up the card.

(3) CAL-BRED REPORT

The third race in the book for fillies three years old, going 300 yards, was called off with five Cal-Bred entries.

THURSDAY

12/30/2010 (1) SCRATCHES

Two rider changes completed scratch time at 9:00 a.m.

(2) THE DRAW

Ten races were drawn for Sunday's program. Four Thoroughbred and six Quarter Horse races complete the card.

(3) CAL-BRED REPORT

Two races were offered Cal-Bred. The second race in the book for maidens, three years old, claiming price \$6,250, going 300 yards, was called off with two Cal-Bred entries. The sixth race in the book for four year olds, claiming price \$8,000, going 330 yards, was also called off with two Cal-Bred.

FRIDAY

There were no changes on the overnight for Sunday's program.

SATURDAY

01/01/2011 (1) OPENING NIGHT

Today was opening night for the scheduled 151 day Quarter Horse and Thoroughbred meet at Los Alamitos.

(2) RULING #1

TRAINER BRET VICKERY, WHO STARTED THE HORSE "LA JOLLA FAMOSA" IN THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON OCTOBER 3, 2010, HAVING ENTERED INTO A STIPULATED AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD, IS FINED THREE THOUSAND DOLLARS (\$3,000)* AND SUSPENDED FOR THIRTY (30) DAYS (JANUARY 3, 2011 THROUGH FEBRUARY 1, 2011) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A) (D) (MEDICATION, DRUGS AND OTHER SUBSTANCES - CLENBUTEROL - CLASS III) AND #1844 (E) (9) & (F) (AUTHORIZED MEDICATION). PURSUANT TO THE TERMS OF THE STIPULATED AGREEMENT, TWENTY (20) DAYS OF THE SUSPENSION ARE STAYED PENDING THE PASSAGE OF ONE YEAR FROM THE DATE OF THIS AGREEMENT, DURING WHICH TIME THE SUBJECT IS PLACED ON PROBATION AND SHALL NOT HAVE ANY VIOLATIONS FOR CLASS I, II, OR III SUBSTANCES. ACTUAL DAYS

This ruling was agreed upon after respondent Bret Vickery consented to an informal hearing.

(3) RULING #2

TRAINER BRET VICKERY IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1845 (A) (AUTHORIZED BLEEDER MEDICATION – CHRB FORM 194 WAS NOT RECEIVED BY THE OFFICIAL VETERINARIAN) ON NOVEMBER 18, 2010.

An informal hearing was held concerning a complaint filed by Official Veterinarian Dr. Beck. Vickery explained he was out of town when the bleeder slip should have been submitted. The trainer accepted responsibility for the infraction.

(4) BAUTISTA RULING

RULING #3

JOCKEY ALEX BAUTISTA IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (B-1) (USE OF WHIPS - WHIPPING IN POST PARADE) ON SUNDAY, DECEMBER 12, 2010.

Jockey Alex Bautista appeared as requested. The rider was observed whipping his mount in the post parade. The rider stated he would stop this practice as he cannot afford the penalty.

(5) ACEVES RULING

RULING #4

JOCKEY RODRIGO ACEVES, WHO RODE "FLYINGWITHEAGLES" IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, DECEMBER 18, 2010, IS SUSPENDED THREE (3) RACING DAYS (JANUARY 8TH, 9TH AND 14TH, 2011) FOR FAILURE TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FIRST TO FIFTH. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

As jockey Rodrigo Aceves is on vacation and could not appear, veteran jockey Alex Bautista represented him at the hearing. After reviewing the replays the Stewards were of the unanimous opinion that jockey Aceves should have prevented the interference he caused. Representative Bautista agreed with this ruling.

(6) ACCIDENT

One sixteenth of a mile past the finish (Quarter Horse – 350 yards) #9 "Da One And Only Fish" (jockey Santiago Mendez) suddenly broke his left front leg and fell. The horse was euthanized on the track. Jockey Mendez was shaken up and was excused from the remainder of his mounts.
