TUESDAY

09/14/2010 (1) DUTY STEWARD

James Dreyer will be present for morning duties and will record the minutes during this reporting period.

(2) CAL-BRED REPORT

The fifth race in the book for Friday, two year olds for a claiming price of \$8,000, was called off with four entries.

(3) THE DRAW

Ten races will be offered Friday evening consisting of one Thoroughbred and nine Quarter Horse races. The PCQHRA Breeders Derby Trials will comprise three of the Quarter Horse events.

SUNDAY

09/19/2010 (1) FILMS

Jay Conklin, at the request of the Stewards, was in to review the first race last evening. His mount, "In Blues Honor," from post #1 managed to drift to approximately the seven hole. The eventual winner, he was very fortunate his mount was in the clear. The Stewards felt it was a very disappointing performance by someone of Jay's caliber.

(2) DR. HACKATHORN EXCUSED

Racing Veterinarian Dr. Hackathorn has taken the evening off and will be replaced by Dr. Karen Peyser.

(3) NICASIO RULING

RULING #100

JOCKEY EDUARDO NICASIO WHO RODE "PARADISE POINT" IN THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, SEPTEMBER 18, 2010, IS SUSPENDED THREE (3) RACING DAYS (SEPTEMBER 26TH, OCTOBER 1ST AND 2ND, 2010) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE IN THE STRETCH, CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

Guild Representative Jay Conklin represented Jockey Eduardo Nicasio at this evening's informal hearing regarding his ride in last evening's seventh race. Jay concurred with us that Eduardo made no effort to maintain a straight course, allowing his mount to drift in causing Jockey Adrian Loza to take up. Had Adrian's mount not closed and beaten Nicasio's mount there would have undoubtedly been a disqualification. After the discussion the foregoing ruling was issued.

(4) OBJECTION – NO CHANGE

Following the fourth race the rider of #7 "El Gato Guapo" (S. Iniguez - 4th) claimed a foul against #8 "Impregnable" (R. Guce - 2nd) during the run down the backstretch. After watching the rerun, the Stewards determined that both horses were moving towards the rail simultaneously and that no interference occurred. The vote was unanimous to make no change.
