Report of the Board of Stewards for the week of July 20, 2010 through July 25, 2010.

TUESDAY

07/20/2010 (1) DUTY STEWARD

Ruben Moreno will be on duty this week, attending to morning office matters and recording the minutes during this reporting period.

(2) ENTRIES AND DRAW

Ten races were drawn for Friday night's card consisting of one Thoroughbred and nine Quarter Horse events. The draw was completed at 1:00 p.m.

(3) CAL-BRED REPORT

The Cal-Bred race offered for California-bred maidens, three years old and upward, claiming price \$6,250 failed to fill with one entry.

WEDNESDAY

07/21/2010 (1) SCRATCHES

Friday scratches were taken at 9:00 a.m. with one scratch, one rider change and eight equipment changes for Friday evening's program.

(2) ENTRIES AND DRAW

Ten races were drawn for Saturday night's card consisting of four Thoroughbred and six Quarter Horse events. The draw was completed at 1:00 p.m.

(3) CAL-BRED REPORT

The Cal-Bred race offered for Cal-bred three year olds, claiming price \$12,500 failed to fill.

Jockey Joel Cruz was in to review his ride in Sunday evening's sixth race where he allowed his mount #7 "Storm J.P." to drift in at the ¼ pole. Jockey Joel Cruz explained he had difficulty with his whip and agreed he could have done a better job and would be more careful in the future. No sanction was given.

(3) PURSE REDISTRIBUTION

RULING #73

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD, THAT URINE SAMPLE# LA15285, TAKEN FROM THE HORSE "BLOKE," WHICH RAN SECOND IN THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON MAY 29, 2010, TESTED POSITIVE FOR 3-HYDROXY LIDOCAINE (CLASS II). IT IS ORDERED THAT "BLOKE" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$1,800) EARNED BY OWNER RAMON O. ALANIS, TRAINER MIGUEL V. RODRIGUEZ, AND JOCKEY SANTIAGO MENDEZ BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY AUGUST 23, 2010 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

ALL RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

(4) DE LA TORRE RULING

RULING #74

TRAINER UGO DE LA TORRE WHO STARTED THE HORSE "DOWNLOAD THIS" IN THE NINTH RACE ON MAY 7, 2010, AT LOS ALAMITOS RACE COURSE IS FINED FIVE HUNDRED DOLLARS (\$500.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1887(A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A, B &D) (MEDICATION, DRUGS AND OTHER SUBSTANCES) AND # 1844 (c-1) (AUTHORIZED MEDICATION - PHENYL BUTAZONE IN EXCESS OF PERMITTED LEVEL (9.71 UG/ML - CLASS IV - FIRST OFFENSE).

Trainer Ugo De La Torre thought there was a mix-up of feed tubs.

(5) POWER OUTAGE

Prior to the start of the tenth and final race of the evening, a three minute power outage occurred. Television cameras and some track lighting were affected but shortly regained power.

(1) FILM REVIEWS

Jockey Genaro Tapia was in to review his ride from the previous evening in the first race where he was slow to correct his mount #5 "Tamale Pie" from lugging out. Jockey Tapia was cautioned to make a better effort. No sanction was given.

Jockey Eulices Gomez was in to review his ride from the previous evening in the first race where his mount #8 "Astormislaunched" drifted out and bumped #9 "Warrens Beauty Mark." Jockey Baltazar Contreras, the rider of #9 "Warrens Beauty Mark," was also present at the film review to speak in affirmation of Gomez's efforts to control his mount. After hearing both jockeys and further film review it was determined that Gomez was making every effort to control his mount and that Contreras' mount actually aided in keeping #8 "Astormislaunched" from drifting out further. No sanction was given.

Jockey Eduardo Nicasio was in to review his ride from the previous evening in the sixth race where his mount #4 "Haleys Cartel" drifted out while breaking from the starting gate and bumping #5 "Go Check Him SA." Jockey Eduardo Nicasio stated his horse was at fault. Nicasio was informed that a better effort would be expected of him in the future. No sanction was given.

(2) FIFTH RACE – INQUIRY – NO CHANGE

After the running of the fifth race (Thoroughbred – 4½ furlongs) the Stewards posted the Inquiry sign to review an incident at the ¼ mile pole involving #5 "Role Model" (jockey Agapito Delgadillo), the eventual winner, and #2 "Phil' Lucky" (jockey Eulices Gomez). After film review and discussion with both jockeys, it was determined that "Phil' Lucky," while running on the inside of "Role Model," went wrong causing his rider to pull up to avoid further mishap. #2 "Phil' Lucky" was later attended to by the Horse Ambulance.

(1) SIXTH RACE – ACCIDENT

During the running of the sixth race (Quarter Horse – 300 yards) #6 “Mr White Boots” unseated his rider, jockey Pablo Huerta, just past the 1/16th pole due to equipment failure when his inside rein broke. “Mr White Boots” continued around the track and was caught by the outrider and jogged back to the Paddock while jockey Huerta, having fallen hard to the track surface was attended to immediately by the track E.M.T.'s. Huerta was able to walk back to the Jockey's Quarters for further evaluation and complaining of a sore wrist was transferred to the hospital. (See attached report.)

(2) SEVENTH RACE – INTERESTING FACT

Trainer Dan Francisco's three starters ran 1-2-3 in the Quarter Horse 300 yard Starter Allowance Race.

(3) NINTH RACE – INQUIRY – NO CHANGE

The Stewards called for an Inquiry following the finish of the ninth race (Quarter Horse – 350 yards) to review an incident at the 16th pole. The replays show #3 “Freaking” (4th – E. Gomez) lugging in on #2 “Royal Miracle Dip” (6th – R. Aceves). After talking to the riders involved and a review of the taped replays, the Stewards unanimously agreed to leave the original order of finish as in their opinion the outcome of the race was not affected as “Royal Miracle Dip” was not in contention for a better placing.

(4) TENTH RACE – INQUIRY – NO CHANGE

Following the running of the tenth race (Quarter Horse – 300 yards) the Stewards called for an Inquiry to review the start. Involved were #7 “Corona Card” (1st – C. Huerta), #6 “Best Fish Yet” (6th – R. Lozano) and #5 “Hawk All The Way” (7th – J. Cruz). The taped replays show that while “Corona Card” veered in at the start, “Best Fish Yet” broke slowly as did “Hawk All The Way.” The Stewards unanimously agreed that no change in the order of finish was necessary as neither “Best Fish Yet” nor “Hawk All The Way” were interefered with to the extent that either horse lost a chance at a better placing.
