TUESDAY

02/23/2010

(1) DUTY STEWARD

(2) CAL-BRED REPORT

The second race in the book for Friday, maiden three and four year olds for a claiming price of \$10,000 was used open after failing to attract a sufficient number of Cal-Breds.

(3) THE DRAW

Three Thoroughbred and five Quarter Horse races will make up Friday evening's eight race program.

(1) SCRATCHES

One equipment change and two scratches completed Friday evening's program changes.

(2) CAL-BRED REPORT

Saturday's second race, Cal-Bred maidens three and four year olds for \$6,250, was called off with three entries.

(3) THE DRAW

Highlighted by the Los Alamitos Maiden Stakes, fans Saturday evening will be treated to a card comprised entirely of Quarter Horse races.

(1) SANCHEZ RULING

RULING #22

JOCKEY RAMON SANCHEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1872 (FAILURE TO FULFILL JOCKEY AGREEMENT) ON FRIDAY, FEBRUARY 26, 2010.

The foregoing ruling was issued after meeting with jockey Sanchez to discuss his failure to fulfill his riding engagement in the third race last evening. His attempt at an explanation was far less than acceptable.

(2) SANCHEZ RULING

RULING #23

JOCKEY RAMON SANCHEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1680 (JOCKEYS AND DRIVERS TO REPORT) ON SATURDAY, FEBRUARY 27, 2010.

The above ruling was issued after jockey Sanchez failed to request permission to be late and arrived thirty minutes prior to the first race.

(3) FIFTH RACE – INQUIRY

The Inquiry was posted following the fifth race to examine the start. "Fire Flying" (6th – Gomez) in post #4 was standing with his head turned toward the five stall for several seconds prior to the start

of the race, losing any chance at a fair start. After speaking with the starter who had already spoken to the assistant starter, the Stewards all felt the fairest thing for all concerned was to declare the horse a non-starter. All monies wagered on "Fire Flying" were refunded.

SUNDAY

02/28/2010 (1) FILMS

Eulices Gomez and Zacharie Kelsey were in to review the eighth race last evening during which they used the horse sandwiched between them as a ping-pong ball. The Stewards felt the incident didn't rise up to the level that required any action on their part, but both riders admitted they were a little negligent.

(2) STARTER AND ASSISTANT STARTER VISIT (REFER 02/27/10 (3))

Starter John Baker and Assistant Starter Joe Garcia were in to discuss last night's incident in the fifth race. There were considerable distractions in the gate involving several horses. #2 "Jess Jet" broke through the gate while #5 "Little Stormer" was trying to climb over the doors. While these distractions were going on, assistant Garcia had his horse's head cocked. When things appeared to settle down, starter Baker said he hollered to get ready; Garcia did not react and Baker kicked the gate, leaving "Fire Flying" standing there with his head turned. Garcia said the blame falls solely on his shoulders. Decision to follow.

(3) GATE MALFUNCTION

The first race was delayed 22 minutes when the starting gate used to start the 4½ furlong races failed. Starter Baker explained that both solenoids failed to function. The gate normally used for the Quarter Horse races was utilized the remainder of the evening.
