Report of the Board of Stewards for the week of November 24, 2009 through November 29, 2009.

TUESDAY

11/24/2009

(1) DUTY STEWARD

Ruben Moreno will be on duty this week, attending to morning office matters and recording the minutes during this reporting period.

(2) SCRATCHES

No scratches for Thursday. Thursday will be dark due to the Thanksgiving holiday.

(3) CAL-BRED REPORT

The first race in the book, California-Bred maiden two year olds at a distance of 300 yards went open with seven horses.

(4) ENTRIES AND DRAW

Nine races were drawn at 11:45 a.m. for Friday night's card, which will consist of seven Quarter Horse and two Thoroughbred events. "Southern California Derby Trials" will be run in three divisions, the sixth, seventh and eighth races.

Friday scratches were taken at 9:00 a.m. with two declarations and two rider changes.

(2) CAL-BRED REPORT

The seventh race in the book, California-Bred three year olds and upward for a claiming price of \$2,000, at a distance of 440 yards, was called off with no entries.

Entries for Saturday were completed at 11:30 a.m. with a nine race card composed of seven
Quarter Horse and two Thoroughbred events.

The first race in the book, California-Bred two year olds, "The Ocean Runaway Handicap," at a distance of 350 yards went with six entries.

Entries for Sunday's card were completed at 12:00 p.m. and consisted of six Quarter Horse and three Thoroughbred events.

No racing due to the Thanksgiving holiday.

Two rider changes accounted for scratch time for Sunday's program.

(2) FIFTH RACE – INQUIRY – DISQUALIFICATION

After the finish of the fifth race (Quarter Horse – 300 yards), the Stewards posted the Inquiry sign to review a bumping incident. Involved were second place finisher #6 "Bail Mary Out" (jockey Rodrigo Aceves) and third place finisher #7 "Kool Illusions" (jockey Guillermo Suarez). After talking with the riders and reviewing the film replays, the Stewards unanimously agreed to disqualify #6 "Bail Mary Out" and place her third behind #7 "Kool Illusions" for interference with the progress of #7 "Kool Illusions," which cost him a better placing. Replays showed #6 "Bail Mary Out" breaking into #7

"Kool

Illusions" and bumping him repeatedly.

Jockey Rodrigo Aceves appeared to review the fifth race from Friday evening where his mount, #6 "Bail Mary Out," was disqualified from second to third place. The films reflected jockey Rodrigo Aceves' mount, "Bail Mary Out," bearing out throughout the race, shifting the blame to the horse for the incident.

Trainer Adan Farias was notified he would be fined for being late to the Receiving Barn on November 27, 2009 at Los Alamitos Race Course. The following ruling was issued.

(1) FIRST RACE – INQUIRY – ACCIDENTS

In the first race (Thoroughbred – 4½ furlongs) #6 "Sutter Butte" (apprentice jockey Genaro Tapia) went wrong, drifted inward, and made contact with #1 "Freedom Class" (jockey Martin Lomeli), who then was pushed inward and onto the rail for several strides. Jockey Tapia jumped from his mount

before the two horses collided, and the collision caused Martin Lomeli to be thrown from his mount. Both jockeys were promptly transported to the hospital; "Sutter Butte" was euthanized on track; and "Freedom Class" was placed on the vet's list due to injury. Accident reports attached. Also occurring in the first race, #2 "True To Summing" stumbled and unseated jockey Dionicio Navarro. Mr. Navarro was evaluated by E.M.T.'s and permitted to continue his riding engagements while "True To Summing" was unharmed. Accident report attached.
