Report of the Board of Stewards for the week of September 15, 2009 through September 20, 2009.

TUESDAY

09/15/2009

(1) **DUTY STEWARD**

Kim Sawyer was available for the morning duties and recorded the minutes for this reporting period.

(2) **SCRATCHES**

Thursday scratches were completed at 9:00 a.m. with two jockey changes and one declaration.

(3) **THE DRAW**

Nine races were carded for Friday's program; the draw concluded at 12:30 p.m. All races offered were Quarter Horse dashes.

WEDNESDAY

09/16/2009

(1) **SCRATCHES**

Friday scratches were conducted at 9:00 a.m. with one declaration off an also-eligible list.

(2) **THE DRAW**

The card for Saturday was completed at 1:15 p.m. and was comprised of eight Quarter Horse and two Thoroughbred races.

THURSDAY

09/17/2009

(1) **SCRATCHES**

Scratches for Saturday's program at 9:00 a.m. were officially complete with two jockey corrections and one declaration.

(2) **THE DRAW**

Nine races were drawn for Sunday consisting of six Quarter Horse and three Thoroughbred races. The draw was completed at 1:00 p.m.

(3) **SIERRA RULING (REFER 09/05/09 (3))**

TRAINER CIRILO SIERRA WHO STARTED THE HORSE "DIXIES MYSTERY" IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON JULY 11, 2009 IS FINED FIVE HUNDRED DOLLARS (\$500.00)* AND SUSPENDED FOR THIRTY (30) DAYS (SEPTEMBER 21, 2009 THROUGH OCTOBER 20, 2009) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1887 (A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A) (D) (MEDICATION, DRUGS, AND OTHER SUBSTANCES - GABAPENTIN - CLASS III).

This ruling was issued after the Board of Stewards deliberated and agreed with the recommended penalty.

(4) PURSE REDISTRIBUTION RULING

RULING #178

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE# 12597, TAKEN FROM THE HORSE "DIXIES MYSTERY", THE FIRST PLACE FINISHER IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON JULY 11, 2009, TESTED POSITIVE FOR GABAPENTIN (CLASS III) A PROHIBITED DRUG SUBSTANCE. IT IS ORDERED THAT "DIXIES MYSTERY" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE (\$2,805) EARNED BY OWNER JAVIER M. SIERRA, TRAINER CIRILO M. SIERRA AND JOCKEY EULICES GOMEZ BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

REVISED ORDER OF FINISH IS AS FOLLOWS:

ALL RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

This ruling was posted after the issuance of Ruling #177.

(5) ESTRADA RULING

RULING #179

JOCKEY J.C. ESTRADA IS HEREBY FINED THE SUM OF ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, SEPTEMBER 13, 2009, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

This ruling was distributed after Mr. Estrada missed his first assigned mount on Sunday evening. He rode the tenth race at Fairplex and was unable to arrive at Los Alamitos in time to participate in the second race. Mr. Estrada apologized and accepted the penalty respectfully.

(6) FIRST RACE – INQUIRY – DISQUALIFICATION

Following the running of the first race (Quarter Horse – 300 yards), the Inquiry sign was posted to review an incident approaching the finish line. Involved were #2 "A Regal Million" (2nd – R. Aceves)

and #3 "Card Check" (5th – F. Rubio). After a review of the videos and conversation with both riders involved, it was a unanimous decision to disqualify #2 from second to fifth place. Late in the race #2 drifts out taking the path of #3, causing that one to check and lose the opportunity for a better placing.

Official Order of Finish: 8 – 6 – 1 – 3 – (2) – 4 – 5

(7) EIGHTH RACE – INQUIRY – DISQUALIFICATION

The Inquiry sign was posted after the finish of the race (Quarter Horse – 300 yards) to review a possible infraction soon after the start. Involved were #1 "Look At This Chick" (3rd – S. Mendez), #2 "Fast Going Chick" (8th – D. Means) and #3 "She Deals" (6th – E. Gomez). #1 drifts out, not clear of #2 causing the latter to take up and shift outward, pushing #3 over the heels of #4 causing #3 to alter course, thus denying both #2 and #3 a better placing. Upon conclusion of the review of the films and talking to all jockeys involved the Stewards agreed #1 be disqualified and placed last behind #2.

FRIDAY

09/18/2009 (1) SCRATCHES

One rider adjustment completed the 9:00 a.m. scratch time for Sunday.

(2) STATE VETERINARIAN REPLACEMENT

William Bell, D.V.M. will replace Gary Beck, D.V.M. for the next three days providing the duties of State Veterinarian for the California Horse Racing Board.

(3) HERNANDEZ INFORMAL HEARING (CASE# 09LA0189)

Trainer Hector Hernandez along with the Board of Stewards and Senior Investigator Tom Blake met after acceptance from Mr. Hernandez for an informal setting. Two witnesses sworn in to testify were Senior Investigator Dennis Drulias for the California Horse Racing Board and owner Victor Gonzalez for the respondent. The issue at hand was a possible violation of California Horse Racing Board rule #1902 (Conduct Detrimental to Horse Racing). This case involved a sick horse being transported onto the Stable Area at Los Alamitos to be examined by one of the practicing veterinarians. It was necessary for the euthanasia of this animal due to the deterioration of its health, and there were concerns whether the horse was a carrier of an infectious disease. The question in this case is whether or not Mr. Hernandez had knowledge or had suggested that the sick horse be transported to Los Alamitos to be examined. After all testimony was heard the hearing was closed and a decision will follow shortly.

(4) FILM REVIEW (REFER 09/17/09 (6&7))

Jockey Rodrigo Aceves and Santiago Mendez both met with the Stewards to review and discuss their involvement in disqualifications in two different races on Thursday evening.

Mr. Aceves' ride in the first race was exonerated due to the fact he was in the process of making the correction of his mount's drift prior to the incident that necessitated the disqualification. Mr. Mendez participated in the eighth race disqualification and was also not penalized because of his effort to correct his horse before the infraction occurred.

(5) FIFTH RACE – TRAINER OBJECTION – NO CHANGE

Following the running of the race (Quarter Horse – 330 yards) the trainer of #3 “Dreaming Royal” (6th – S. Mendez) Jose De La Torre called the Stewards to lodge a claim of foul against #2 “Spirited Away” (3rd – J. Andrade). After a review of the films and conversation with the riders involved it was a unanimous decision to let the original order of finish stand. The De La Torre trainee actually drifted out into #4 to his outside bumping that one. #2 was not involved.

(2) HERNANDEZ RULING (REFER 09/18/09 (1))

RULING #180

TRAINER HECTOR HERNANDEZ IS FINED THREE HUNDRED DOLLARS (\$300.00) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1902 (CONDUCT DETRIMENTAL TO HORSE RACING).

After digesting all the facts and testimony of this case the Stewards agreed upon the foregoing ruling.

(3) HO RULING

RULING #181

TRAINER HERBERT HO IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1845 (A) (AUTHORIZED BLEEDER MEDICATION - HORSE NOT REGISTERED AT TIME OF ENTRY) ON SEPTEMBER 3, 2009.

This ruling was issued after a telephonic hearing was performed wherein Mr. Ho felt his practicing veterinarian was to blame. After Mr. Ho was informed he is the responsible party he accepted the penalty.

(4) FILM REVIEW

Jockey Ramon Sanchez met with the Stewards to discuss the drift of his mount in the second race. The films verified that Mr. Sanchez did make an effort to guide with the reins, but the Stewards requested in this situation he put the stick away and pull harder. He agreed to do so in the future.

The ten race card was conducted without noteworthy incident.

09/20/2009 (1) INFORMAL TELEPHONIC HEARING (CASE# 09LA0212)

Owner Jeremy Kelton called the Stewards and was granted the opportunity to adjudicate his case via a conference call concerning a possible violation of California Horse Racing Board rules #1890 (Possession of Contraband) and #1891 (Seizure of Contraband). Mr. Kelton stated the medication he had in the truck was used only when needed if the horses got frantic or fractious while being transported. Mr. Kelton admitted his lack of knowledge of the California Horse Racing Board rules

and was unaware that this kind of paraphernalia was not allowed on race track property. Decision to follow.
