Report of the Board of Stewards for the week of February 19, 2008 through February 24, 2008.

TUESDAY
02/19/2008

- (1) DUTY STEWARD
Martin Hamilton was the duty Steward this week attending to all morning office matters and recorded the minutes during this reporting period.
- (2) SCRATCHES FOR THURSDAY
Two rider changes were the only corrections for Thursday's program.
- (3) ENTRIES FOR FRIDAY
One Arabian, three Thoroughbred and six Quarter Horse races were drawn for Friday's card, completed at 12:30 p.m.

WEDNESDAY

- (1) SCRATCHES FOR FRIDAY
One rider change comprised scratch time for Friday at 9:00 a.m.
- (2) ENTRIES FOR SATURDAY
Eleven races made up the card for Saturday consisting of three Thoroughbred and eight Quarter Horse events. The draw was completed at 1:30 p.m.

THURSDAY

02/21/2008

(1) SCRATCHES FOR SATURDAY

Two declarations and three rider changes were approved at the 9:00 a.m. scratch time for Saturday.

(2) ENTRIES FOR SUNDAY

One Arabian, one Thoroughbred and seven Quarter Horse races completed the nine race program for Sunday. The draw was finalized at 12:30 p.m.

(3) PAUL AGUIRRE RULINGRULING # 61

TRAINER PAUL AGUIRRE WHO STARTED THE HORSE "SODA POP SYD" IN THE FIRST RACE ON OCTOBER 25, 2007, AT LOS ALAMITOS RACE COURSE IS FINED EIGHT HUNDRED DOLLARS (\$800.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1887(A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES – FLUNIXIN IN EXCESS OF PERMITTED LEVEL CLASS VI), AND #1844 (B-C-2) (AUTHORIZED MEDICATION – RACE DAY ADMINISTRATION).

The above noted ruling was issued following due deliberation over testimony and documentary evidence presented in a formal hearing held on February 16, 2008. (Refer 02/16/2008 (4)).

(4) MARK WHITAKER RULINGRULING # 62

HAVING SATISFIED A DEBT TO EQUINE SPORTS MEDICINE, OWNER MARK WHITAKER IS HEREBY RESTORED TO GOOD STANDING. RULING # 49 ISSUED AT LOS ALAMITOS RACE COURSE ON FEBRUARY 8, 2008, FOR FAILURE TO APPEAR, IS HEREBY SET ASIDE.

The foregoing ruling was written when the board of Stewards received written notice that Mr. Whitaker had satisfied his outstanding account with Equine Sports Medicine by paying in full.

(5) CAL-BRED REPORT

The Cal-Bred race offered for maidens, three years old and upward, claiming price \$5,000, going 300 yards received no entries.

(6) INQUIRIES – 3RD RACE – DOUBLE DISQUALIFICATION

Following the third race the Stewards posted the Inquiry sign to review interference 80 yards after the start involving # 1 "On High Cee" (4th – jockey Eulices Gomez), # 4 "Jetago Rime" (5th – jockey Joel Cruz), # 3 "Flashy Netas" (6th – jockey Cody Jensen) and # 2 "Movin' Mountains" (7th – jockey Dihigi Gladney).

Films show # 1 drifted out in the path of # 2 and # 4 drifted into the path of # 3 costing both # 2 and # 3 a chance at a better placing.

Following a thorough review and after talking to the riders involved # 1 and # 4 were both disqualified from 4th and 5th and placed 6th and 7th respectively in a unanimous decision.

(1) CAL-BRED REPORT

The Cal-Bred race written for three year olds and upward, claiming price \$5,000, at a distance of 300 yards was called off with one entry received.

(2) MARY PATINO (CASE# 08LA0004)

The above referenced financial complaint filed against owner Mary Patino by trainer Jesus Nunez for training services rendered was dismissed when Mr. Nunez failed to be present to represent his interests.

(3) FILM REVIEW

Jockeys Joel Cruz and Eulices Gomez were in, as directed, to review the third race from last evening where both were disqualified for interference. Films convey both horses drifted subtly contributing to the situation, however, majority of the blame was shifted to the horses. Jockey Gomez, new to Quarter Horse racing, was cautioned to react quicker when mounts go on the drift.

(4) INQUIRY – 10TH RACE - DISQUALIFICATION

The Stewards posted the Inquiry sign following the tenth race for a review of an incident 100 yards after the start of the 300 yard Quarter Horse event.

Films show # 1 "Check This Noble" with jockey Ramon Sanchez ducked out sharply passing the gap and bumped # 2 "Dreamers Okie" (6th – jockey Juan Andrade) into # 4 "Armando Duke" (9th – jockey Dorothy Williams), costing the latter two the opportunity at better placings.

Following a review of the tapes of the race, and after talking the riders involved, # 1 was disqualified from fifth and placed eighth.

(1) ENTRIES FOR THURSDAY

One Arabian, two Thoroughbred and five Quarter Horse races make up the card for next Thursday. The draw was completed at 1:00 p.m.

(2) CAL-BRED REPORT

The Cal-Bred race offered for three year olds and upward, claiming price \$2,000, going 870 yards failed to fill Cal-Bred with three and was used open with eight going postward in the third race on the evening.

(3) PAUL JONES (CASE# 08LA0047)

Trainer Paul Jones appeared to address the above noted complaint issued when he entered for a race on February 8, 2008 and neglected to notify the Racing Office that the horse had been gelded since his last race. Mr. Jones took full responsibility for the oversight stating that he should have checked him when he returned from being turned out at the farm. At the conclusion the following ruling was written.

RULING # 65

TRAINER PAUL JONES IS FINED FIVE HUNDRED DOLLARS (\$500.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1865 (ALTERING SEX OF HORSE) ON FRIDAY, FEBRUARY 8, 2008.

(4) PAUL PRICE (CASE# 08LA0046)

Trainer Paul Price appeared to respond to the above referenced complaint filed when his horse "Shake The Dice" tested positive for Dexamethasone on January 24, 2008. Mr. Price accepted full responsibility by admitting that his timing for withdrawal was off and accepted the following ruling.

RULING # 66

TRAINER PAUL PRICE WHO STARTED THE HORSE "SHAKE THE DICE" IN THE SEVENTH RACE ON JANUARY 24, 2008, AT LOS ALAMITOS RACE COURSE IS FINED FOUR HUNDRED DOLLARS (\$400.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1887(A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES – DEXAMETHASONE – CLASS VI).

(5) OBJECTION – 11TH RACE – NO CHANGE

Following the eleventh race, jockey Raul Ramirez, Jr. astride second place finisher # 6 "Baringo" lodged a claim of foul against first place finisher " 3 "Rich And Foxy Man" and jockey Santiago Mendez for alleged interference during the running of the 300 yard Quarter Horse finale.

Films show the two rivals brushed mid-race in what was deemed a 50/50 exchange. Accordingly, no change was warranted.
