The Stewards had the Inquiry sign posted immediately following the running of the fifth race to evaluate an incident at the start which involved # 2 "Shine Dat" (3<sup>rd</sup> – jockey C. Huerta), # 3 "Super Sly" (7<sup>th</sup> – jockey R. Aceves), # 4 "I Lov Boots" (6<sup>th</sup> – jockey R. Guce) and # 5 "Dashin Is Requested" (2<sup>nd</sup> – jockey J. Cruz).

After speaking with the riders involved and reviewing the tape replays, the Stewards unanimously agreed to disqualify both # 2 and # 5 from second and third position to sixth and seventh position.

Replays show # 2 breaking out at the start and # 5 breaking in severely impeding # 3 and # 4 simultaneously.
