Report of the Board of Stewards for the week of September 13, 2015 through September 19, 2015.

SUNDAY09/13/15¹**JOCKEY FILM REVIEW**

Don LeBlanc met with the Stewards to review the second race yesterday. There was a bumping incident he was involved in soon after the start of the race. Although there were other horses involved, the Stewards felt he should have eased out of the situation sooner. He agreed, warning. He was also warned about using his crop on a horse when it is clearly out of the race. He stated it wouldn't happen again.

Miguel Perez was also in to talk about the use of the crop. There was no violation, but we wanted to make sure he understood the riding crop rule and to not use it when the horse has reached its maximum placing. He said he understood.

Gary Boag came in a day late to review the first race Friday, the incident involved two other horses folding into the turn in the five and a half furlong event. After much discussion it was decided that Mr. Boag did shift in when changing leads, with a horse to his inside on his heels, and at the same time a horse directly to his inside stepped out. The horse in the middle should have eased back sooner. Warning.

Mr. Boag was excused from a penalty for not being present for the films the day before. It was verified he was not informed of the hearing.

Edwin Maldonado appeared, a day late to review an incident in the sixth race on Friday. Mr. Maldonado's mount ducked out from a left-handed strike of the crop, in front of a horse to his outside, putting that one on his heels. He did correct immediately and left with a warning. He also left with the following ruling:

RULING LAFL #004

Jockey EDWIN MALDONADO is fined FIFTY DOLLARS (\$50.00)* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to attend film review).

09/17/15²**LAWSON RULING**

The following ruling was issued after Mr. Lawson admitted he did not honor a call given in the ninth race Sunday to trainer T. R. Bell II. At the draw, he removed himself from Mr. Bell's entry and chose to ride the eventual winner of race for trainer Martin Jones.

RULING LAFL #005

Pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations), Jockey Agent DEREK LAWSON is fined TWO HUNDRED DOLLARS (\$200.00)* for failure to handle his business in a proper manner (failure to honor call).

09/17/15³**JOCKEY FILM REVIEW**

Efrain Hernandez met with the Stewards to discuss the fifth race (five furlongs) on Sunday. Mr. Hernandez, after the break, made the lead and crossed over quickly from the number ten stall, This was not worthy of a penalty and Mr. Hernandez was very candid in acknowledging he can and will do better; warning.

Apprentice Cassidy Clerisse also reviewed the same race in which her horse, last leaving the gate, made a dramatic move to the fence. After a review, it looked like the horse saw the inside fence before Ms. Clerisse did. This BOS wanted to help her see and learn from the discussion of how she might better handle a situation of this type in the future. She was cautioned to be more aware.

09/17/15⁴**PEREZ RULING**

The following ruling was issued after a review of the race with Mr. Perez and the verification that he violated the whip rule.

RULING LAFL #006

Jockey MIGUEL PEREZ is fined TWO HUNDRED DOLLARS (\$200.00)* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond - first offense), during the first race at Los Alamitos Race Course on September 13, 2015.

CARCAMO RULING

The CHRB filed a complaint against groom Marvin Carcamo for an alleged violation of CHRB rule 1874 (Disorderly Conduct). The following ruling was issued after Mr. Carcamo failed to appear for the scheduled hearing.

RULING LAFL #007

Groom MARVIN CARCAMO, having failed to respond to charges alleging violation of California Horse Racing Board rules 1874 (Disorderly Conduct – intoxicated - threatening with a weapon) is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear). During the term of suspension, all licenses and license privileges of MARVIN CARCAMO are suspended and pursuant of California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. CARCAMO is denied access to all premises in this jurisdiction.

GARCIA HEARING CASE #DM096

The CHRB filed a complaint against trainer Mario Garcia for an alleged violation of CHRB rule #1588 (j) (Horse Ineligible to Start in a Race), #1502 (Program Trainer Prohibited) and #1887 (Trainer to Insure Condition of Horse). After the horse started at Del Mar Race Track, it was discovered that Mr. Garcia shipped in from a farm the morning of the race. This violates the CHRB rule #1588 which requires any runner not stabled at an approved auxiliary stabling facility and has not received permission from the acting BOS to ship in later than twenty four hours is not eligible to start. After some discussion it was decided, complaints should also be filed against the van driver and the owner of the horse and any other licensees involved in this incident. This hearing was continued until all involved could be served their complaints. More to follow.

INQUIRY/ ACCIDENT/ SIXTH RACE/ NO CHANGE

An accident occurred approaching the 3/8 marker in the 5 1/2 furlong event. It appeared on the review of the video that #3 Discreetlyhumorme (Flavien Prat) stumbled while outside of one horse, inside of two horses, fell unseating the rider. #2 Lucky Snow (Santiago Gonzalez) jumped the fallen horse, stumbled and fell unseating his jockey. Both ambulances were on scene immediately and transported the riders to waiting Paramedics. No other horses in the race were involved and the race was made official. Accident reports attached.

Apprentice Wilian Chavez stopped in to discuss his ride in the last race yesterday. He was given advice as to how he could better handle negotiating the turn. And in the stretch, he was counseled to hit less and use his reins to guide his horse. He was very appreciative of the advice.

Carlos Marquez also met with the BOS to review the fifth race yesterday. It was explained to him that with the configuration of this race track, on the backstretch, it is better to go straight rather than try and to follow the fence. Once he saw it on the video he understood and was thankful for the information.

09/19/15²**FORMAL HEARING/ PURSE REDISTRIBUTION/ CASE #15DM0044**

The CHRB filed complaints against trainer Tim Yakteen, who did not receive a percentage of the purse, owner opted to not automatically pay percentage of the win purse, that complaint was withdrawn; owner George Krikorian; and jockey Rafael Bejarano under CHRB rule 1859.5 (Disqualification Upon Positive Test Findings). Supervising Investigator Rick Amieva represented the CHRB and Court Reporter Michelle Derieg documented the proceedings. Rafael Bejarano was present, Mr. Yakteen and Mr. Krikorian chose not to attend. The facts of the case were read into the record as follows: the horse "Big Book" who ran in the third race at Del Mar Race Track, finished first and tested positive for the drug, Acepromazine (259 ng/mL-Class III). 10 ng/mL is the level not to be exceeded. All documents were entered into evidence and the hearing was closed. A ruling will follow.

09/19/15³**QUEVEDO HEARING #15DM0002**

The CHRB filed a complaint against groom Leonardo Quevedo for an alleged violation of CHRB rules 1902 (Conduct Detrimental to Horse Racing) and 1489 (h) (Grounds for Denial or Refusal of License). Mr. Quevedo was charged with a violation of Health and Safety Code 11377 (A), possession of a controlled substance, Methamphetamine. Mr. Quevedo was granted a "Deferred Entry of Judgment" for eighteen months. He failed to appear for a DEJ report, criminal proceedings were reinstated and a bench warrant was issued in the amount of \$10,000.00. Mr. Quevedo also failed to appear for the scheduled hearing. Ruling to follow.
