9/12/12² **STARTING GATE PLACEMENT PROBLEM**

During the morning hours between the end of training and shortly before the starting gate was to be set for the first race (about 4 furlongs), some unknown idiot parked a van in the corner of the chute, preventing the gate from being set at the proper distance. Efforts to locate the person proved fruitless and the van could not be moved. The Stewards made the decision that since the race was advertised at an "about" distance, the gate was moved approximately ten feet forward and the race went on without incident. There were two other races later in the card run in the same manner. Ultimately, a tow truck was called and the vehicle was removed.

9/12/12³ **ACCIDENT/INQUIRY/NO CHANGE**

The Inquiry sign was posted after the third race (6 ½ furlongs) as the Stewards reviewed an incident shortly after the start involving #1 SEA OF DESIRE, ridden by JORGE CARRENO. After taking into account reports from the Patrol Judges and reviewing video of the incident, the Stewards voted unanimously to make no change in the placings. Review showed the horse ducking into the temporary railing, unseating the rider in the process. The loose horse caused no problems for the other starters. CARRENO was excused from his next mount while being examined by the track physician, but completed his remaining engagements. Accident report attached.

9/12/12⁴ **REFUND**

A refund was ordered in the fourth race when #6 GHOSTLY FEVER flipped in the saddling paddock and was declared on the recommendation of Racing Veterinarian STEAD. The refund amounted to \$5,853.84. Jockey OSWALDO MACIAS was not injured.

9/12/12⁵**ACCIDENT/ INQUIRY/NO CHANGE**

The Inquiry sign was posted after the seventh race to review circumstances which resulted in jockey MARTIN PEDROZA being unseated from his mount, #7 WARREN'S TYLER S., in the first turn of the six furlong event. After speaking with the Patrol Judges and reviewing video of the race, the Stewards made no change to the original order of finish. The accident was caused as PEDROZA's mount bore out on the turn and got its right foreleg tangled up with the left front leg of the horse to its outside, #8 SLIPPERY SLEWP. This resulted in WARREN'S TYLER S. stumbling sharply, tossing PEDROZA to the track. He was removed by the paramedic unit and transported to Pomona Valley Medical Center for observation. Replacement riders were named.

9/13/12²**RIDER EXCUSED**

Jockey MARTIN PEDROZA, who was involved in a spill in the seventh race yesterday (9/12/12⁵), was excused from eight mounts this afternoon as he was suffering the effects of the accident. Replacement riders were named.

9/13/12³**RULING – LAFP #001**

Owner EVELYN UNGARO, having failed to appear to respond to a complaint alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility – Von Bluecher, Blea, Hunkin, Inc., \$8,508.95) is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of EVELYN UNGARO are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Ms. UNGARO is denied access to all premises in this jurisdiction.

This ruling was issued after Ms. UNGARO failed to appear for a hearing regarding a complaint filed against her for unpaid veterinary bills.

9/13/12⁴**MEETING WITH PARAMEDICS**

The Stewards held a meeting with the paramedic crew regarding the two spills which took place yesterday and the manner in which they responded. Of particular concern was the seemingly long response time for the first spill, which occurred at the six furlong gap. The rider was in a position on the track which would have required the race be called off if he could not have been moved. The assistant starters ultimately moved the rider and only then was he attended to by the paramedics. We stressed the importance of a quick response, not only for the health of the jockey, but also should the race have to be cancelled.

9/15/12²**FORMAL HEARING – ESWAN FLORES**

A formal hearing was held this morning into a complaint filed against Apprentice Jockey ESWAN FLORES for violation of California Horse Racing Board rule #1500.1 (Random Drug Testing) in that he tested positive for a metabolite of cocaine during a random drug test on August 23, 2012 at Del Mar. The original sample, tested by Quest Diagnostic Laboratory, indicated the presence of 2,460 ng/ml of cocaine metabolites. The split sample requested by Mr. FLORES was tested at Pharmatech Laboratories and confirmed the original findings although there was no quantification noted. Present at the hearing were the Board of Stewards, Mr. ESWAN FLORES who was represented by attorney ROGER LICHT, and Deputy Attorney PATRICIA NEVONEN, counsel for the Board. BARBARA WEINSTEIN recorded the proceedings.

Investigator RICK AMIEVA testified as to how the selection process worked and showed those in attendance just how the chain of custody was maintained. He also explained the procedure to Mr. FLORES in a step by step manner.

Mr. TED JOHNSON, the custodian of records for Quest Diagnostics, testified as to the findings and the methodology behind the testing. He also testified that the second test requested by Mr. FLORES' counsel was below the cutoff level of 300 ng/ml and thereby technically "negative," although there was a small amount of the drug in that sample as well.

Mr. ESWAN FLORES testified in his defense and stated that he did not knowingly use cocaine during the Del Mar meeting. He did state, however, that he used "pills" for weight control obtained from a "friend of a friend" which were procured in Tijuana, Mexico. He did not know the ingredients contained in the pills. He thinks the pills might have contained Lasix but was not certain. He said each bottle contained fifty pills but did not recall how many of the bottles he used. Finally, he testified that he still has the pills in his possession but is no longer using them.

In closing, Ms. NEVONEN said that opposing counsel did not argue the findings of either laboratory and that Mr. FLORES' ignorance of the law or the contents of the pills he was using was no excuse.

Mr. LICHT felt that his client had suffered an enormous penalty already in that he has not been allowed to ride since August 25, 2012, while being in contention for the Eclipse Award for leading apprentice jockey. He said the nineteen-year-old is not a threat to horse racing, is remorseful, is working on his weight without resorting to medication, and will test daily at his own expense. He also requested that the Stewards extend Mr. FLORES' apprenticeship for a like number of days that he has been denied the privilege of riding.

A decision will be rendered shortly.

9/15/12³**FINANCIAL COMPLAINT SETTLED**

A financial complaint in the amount of \$1,735.00, filed by exercise rider PEDRO ZAVALA against trainer NICOLAS ACUNA, was settled today as Mr. ACUNA agreed to a payment plan.

9/15/12⁴

STEWARDS' INQUIRY AND DISQUALIFICATION

The Stewards posted the Inquiry sign after the first race to review an incident at mid-stretch between the first two finishers, #4 BOCA BAY (J. Hernandez), and #3 GO TO THE PULPIT (M. Pedroza). After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing video of the incident, the Stewards voted unanimously to disqualify BOCA BAY from first to second position. Video shows that horse ducking out after being hit with left-hand whip, taking the path of GO TO THE PULPIT and forcing jockey PEDROZA to alter his course. PEDROZA's horse continued to close strongly after the incident and was beaten a "head" for the win. It was the Stewards' opinion that GO TO THE PULPIT was denied the win by the actions of the original winner.

9/15/12⁵

REFUND

A refund was ordered in the seventh race as #2 MIDNIGHT PRAYER unseated the rider, VINNIE BEDNAR, and ran off into the stable area. The refund from the scratch amounted to \$10,059.76.

NOTE: We later learned that this was the third time the horse has pulled the same stunt and has yet to make it to the starting gate. The filly will be barred from racing in this jurisdiction.

9/15/12⁶

REFUND

The Stewards ordered a refund in the last race of the day when Racing Veterinarian STEAD recommended that #6 DESTINO be declared for being unsound during the warm up period. There was a total of \$14,818.34 refunded to the players.

9/16/12³**RULING – LAFP #002**

Apprentice jockey ESWAN FLORES is suspended for sixty (60) calendar days, from August 25, 2012 to October 23, 2012, pursuant to California Horse Racing Board rule 1500.1 (Random Drug Testing – positive test for cocaine metabolites) on August 23, 2012 at Del Mar Race Track. Prior to the reinstatement of Mr. FLORES' license, he must sign a testing agreement with the California Horse Racing Board, arrange a consultation with the Winners' Foundation and abide by their recommendations. Lastly, Mr. FLORES is not eligible for an extension to his apprentice license based on the suspension described herein.

During the term of the suspension, all licenses and license privileges of ESWAN FLORES are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine) Mr. FLORES is denied access to all premises within the jurisdiction.

This ruling was issued after the Stewards discussed the merits of the case against the rider.
