9/9/11³**REFUND**

A refund was ordered in the first race as #5 VIREBE flipped during the saddling procedure and was declared on the recommendation of Racing Veterinarian STEAD. The amount returned came to \$2,686.00.

9/9/11⁴**HORSE COLLAPSES**

The opening day program was marred by the death of the winner of the third race, eleven year old PROUD CARDENAL. The horse went down while leaving the winners' circle, got to its feet, then fell again, this time hitting its neck and withers against the outside running rail in the process. Racing Veterinarian STEAD was on the scene immediately, but his efforts were in vain. The horse likely died of post exertion distress or heat stroke.

9/10/11²**OPENING DAY PROBLEMS**

There were several glitches occurring during the first racing card; most notably, the infield tote board experienced problems for a great portion of the card, being fully operational for the final race. Additionally, there were telephone outages and a problem communicating with the Patrol Judges on their headsets. These were remedied during the racing program.

9/10/11³**RULING – LAFP #001**

Jockey JOY SCOTT, who rode HAPPYHOOFERTO in the seventh race at the Los Angeles County Fair (Fairplex Park), on Friday, September 9, 2011, is suspended three (3) racing days (September 16, 17, 18, 2011) for crossing over without sufficient clearance, a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

This ruling was issued after Ms. SCOTT viewed video of the fourth race from Friday, during which her horse was responsible for interference entering the final turn of the six and one-half furlong event. She felt that the leader's errant path caused her to alter her course but review showed that there was no significant pressure applied.

9/10/11⁴**STEWARDS' INQUIRY – NO CHANGE**

The Stewards posted the Inquiry sign after the first race to review an incident in the closing yards involving the second and third place finishers, #4 BIGMIKEISTHEMAN (C. S. Reyes) and #1 BRYAN DANIEL (A. Delgadillo). After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing video of the incident, the Stewards voted unanimously to make no change in the placings. Review showed that while DELGADILLO steadied in the closing strides in order to avoid heels, his mount was third at the time of the incident and finished in that position.

9/10/11⁵**RIDER EXCUSED**

DIHIGI GLADNEY was excused from his mount in the seventh race this afternoon as he was still suffering the effects of a spill he had at Los Alamitos last evening. A replacement rider was named.

9/11/11²**VIDEO REVIEW**

Three riders were in the office this morning to review races from Saturday, CHRISTIAN SANTIAGO REYES, who was involved in an Inquiry in the first race yesterday, received a warning for drifting in during the stretch run; PEDRO ARAMBULA was in to take a look at the second race and was admonished for not correcting his mount sooner when it broke in at the start; JOSE VALDIVIA, Jr., just back from a stint on the east coast where he won the Belmont Stakes this past June, was in the office to review the sixth race from Saturday, during which he permitted his mount to drift out in late stretch to make contact with the eventual winner. VALDIVIA had no excuse; however, after review, it was determined that contact took place after the finish. Mr. STAUFFER was a dissenting vote with respect to REYES and ARAMBULA, while Mr. CHANEY dissented in the VALDIVIA matter.

9/11/11³**COMPLAINT SETTLED**

A financial complaint filed by trainer SIMON CALLAGHAN against owner PATRICK O’SULLIVAN was settled as the two agreed on a compromised figure and O’SULLIVAN proffered a check for the amount agreed upon.

9/11/11⁴**ACCIDENT/INQUIRY/NO CHANGE**

The Inquiry sign was posted after the second race to review the circumstances which caused jockey JOY SCOTT, aboard #4 HARD EIGHT, to be unseated from her mount at the start. After speaking with the Patrol Judges and reviewing video of the incident, the Stewards voted to make no change in the placings. Video showed that Ms. SCOTT left the gate with only one hand on the reins, losing her balance and falling off of the horse’s hind end. She was not injured and completed her remaining engagements after being examined by the track physician.

9/11/11⁵**ACCIDENT/INQUIRY/NO CHANGE**

The Stewards posted the Inquiry sign after the fourth race to review the circumstances which resulted in jockey DEE DEE WILLIAMS being unseated from her mount, #4 CLEAR THE SET, in the final turn. After speaking with the Patrol Judges and reviewing video of the incident, the Stewards voted unanimously to make no change in the placings. Review showed that her horse bolted and the rider bailed off just before the horse got to the outside fence.
