ENTRIES AND DRAW

The entries for Friday were drawn at 12:00 p.m. and the card will consist of one Mule, one Arabian, and nine Thoroughbred races.

CAL-BRED REPORT

The third, tenth, and twelfth races on today's program will be contested for California-breds exclusively.

9/12/10³

FELIPE VALDEZ HEARING (Case #10DM025)

Jockey FELIPE VALDEZ appeared as directed to answer to the above referenced complaint concerning a violation of CHRB rule #1688 (Use of Whips) that occurred at Del Mar on August 18, 2010. Mr. VALDEZ was informed of his right to representation, which he declined, and the recorded Hearing was opened.

Present at this Hearing were: the Board of Stewards, RANDY WINICK, DARREL McHARGUE, and JON WHITE; Senior Special Investigator PHIL MIYAZAKI, and the respondent, Jockey FELIPE VALDEZ.

Steward WINICK opened the Hearing by reading and explaining the charges, along with the possible penalty. Jockey VALDEZ gave his explanation which centered on him having a new whip that was of a rather hard texture and may have caused undo damage to the horse. He has now changed his equipment to alleviate this problem in the future. FELIPE admitted to his transgression in this matter.

The Stewards informed Mr. VALDEZ that we would deliberate on his penalty and that his previous violation for a similar issue would be taken into consideration. Decision to follow.

9/12/10⁴ **REYES RULING – LAFP #002**

Jockey CHRISTIAN SANTIAGO REYES, who was scheduled to ride PLAYA COCO in the first race at the Los Angeles County Fair, on Saturday, September 11, 2010, is hereby fined the sum of ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board Rule #1872 (Failure to Fulfill Jockey Agreement) causing a late rider change.

The above ruling was issued to Jockey CHRISTIAN SANTIAGO REYES for failure to fulfill his riding engagement in Saturday's first race, due to his misunderstanding of which races he was in and that he thought the first race of the day was a Mule race.

The Stewards informed Mr. REYES that he must be more responsible in knowing his riding assignments.

9/12/10⁵ **VELAZQUEZ RULING – LAFP #003**

Apprentice Jockey JESUS VELAZQUEZ, who rode BUBSY in the fifth race at the Los Angeles County Fair on Saturday, September 11, 2010, is suspended THREE (3) RACING DAYS (September 18, 19, and 22, 2010, for altering course without sufficient clearance, causing interference resulting in the disqualification of his mount from first to second place, a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued to Apprentice Jockey JESUS VELAZQUEZ after he was in to review the film from the previous afternoon's fifth race from which his mount was disqualified from first to second place for altering course turning for home in the six-furlong thoroughbred race. Mr. VELAZQUEZ had no reasonable explanation for coming off his rail position around the 3/16 turn to the middle of the track and interfering with the horse to his immediate outside. The Stewards explained to the young rider that he must be aware of his position at all times and not to be too aggressive.

SCRATCHES

Scratch time for Wednesday's program was at 10:00 a.m., Tuesday. There were two declarations and one rider change.

WEDNESDAY9/15/10¹**SCRATCHES**

The 10:00 a.m. scratch time resulted in two rider changes and one equipment adjustment.

9/15/10² **ENTRIES AND DRAW**
Saturday's draw commenced at 12:45 p.m., and the ensuing card will be comprised of eleven thoroughbred races and one Arabian race.

9/15/10³ **CAL-BRED RACE**
The fifth race on today's program is for California-bred two-year-old maidens, with a claiming price of \$32,000 at six furlongs. A field of seven is scheduled to face the starter.

9/15/10⁴ **FILM REVIEW**
Jockey FELIPE VALDEZ was in as instructed to review Sunday's fourth race where his mount broke out, then angled inward, running somewhat erratically. The Stewards told Mr. VALDEZ to make a better effort, but also understood that he was on a green two year old. No sanction was given.

9/15/10⁵ **PERIBAN COMPLAINT (Case #10DM043)**
Trainer JORGE PERIBAN came in to address the above-referenced complaint (informally) concerning being late to the receiving barn at Del Mar on September 4, 2010. Mr. PERIBAN told the Stewards that the gap he usually passes through to get to the front side receiving barn was closed and that he had to go the long way around. The Stewards issued a warning to JORGE due to this being his first offense.

9/15/10⁶ **VALDEZ RULING – LAFP #4 (Refer 9/12/10³)**
Jockey FELIPE S. VALDEZ is fined the sum of ONE THOUSAND DOLLARS (\$1,000.00)* for violation of California Horse Racing Board rule #1688(b)(3) (Use of Whips) while riding the horse CAJUN GENT in the third race on August 18, 2010 at Del Mar Race Course.

The above ruling was issued to Jockey FELIPE VALDEZ after deliberation on Sunday's Hearing into his misuse of the whip violation. The Stewards thought it appropriate to increase the fine due to this being his third violation this year.

9/15/10⁷ **NO SHOW WAGERING – FIRST RACE**
There will be no Show wagering in today's first race (350 yards – Mule) due to the presence of a prohibitive favorite, which is anticipated to cause a large minus pool.

9/15/10⁸ **INQUIRY/OBJECTION – FIRST RACE – NO CHANGE**
Following the finish of the first race (350 yards – Mule) the Stewards posted the inquiry sign as well as acknowledging an objection by the rider of #5 PRISCILLA NELSON (4th – J. Scott) for alleged interference through the stretch. The interference involved #4 EARS LOOKINGATYOU (1st – R. Boyce) on the outside of #5 and also #1A BAR JF EASY MONEY (2nd – J. Wooten, Jr.) on the inside of #5, making contact and causing interference.

After speaking to the riders involved and reviewing the tape replay, the Stewards ruled that there be no change to the original order of finish. It was determined that #1A was marginally involved and that #4 and #5 were making equal contact with each other and both were contributing to the problem.

9/15/10⁹ **OBJECTION – SIXTH RACE – NO CHANGE**

Jockey CHRISTIAN SANTIAGO REYES, aboard #4 PARTY MANDATE (2nd) lodged an objection against #2 GENTLE ROMEO (1st – M. Pedroza) for drifting out inside the final sixteenth of a mile in the six-furlong sixth race, making contact with him and causing interference.

After speaking to both riders and viewing the tape replay, the Stewards unanimously made no change to the original order of finish, as the contact was minimal and did not cost #4 a better placing.

9/16/10² **ENTRIES AND DRAW**

Entries for Sunday were completed at 1:00 p.m., with a card of twelve races comprised entirely of Thoroughbreds.

9/16/10³ **CAL-BRED REPORT**

The tenth race on today's program will be for California-bred fillies and mares, three years old and upward which have never won \$10,000 other than maiden, claiming, or starter or claiming price \$40,000. Nine ladies are scheduled to face the starter.

9/16/10⁴ **BLAKE HEAP COMPLAINT (Case #10DM044) – RULING LAFP #005**

Trainer BLAKE R. HEAP is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn – Late – 2nd offense), and #1894 (Duties of Trainer), on September 4, 2010, at Del Mar Thoroughbred Club.

The above ruling was issued to trainer BLAKE HEAP after a telephonic Hearing where Mr. HEAP admitted to his transgression but added the caveat that he was late due to the entrance gap on the track being closed and, therefore, he had to take an alternate path. The Stewards told Mr. HEAP it is his responsibility to arrive on time to the receiving barn and that this was his second offense for this issue.

9/16/10⁵ **JIMENEZ RULING – LAFP #006**

Jockey ALEX JIMENEZ, who rode GETSETGETREADYGO in the fifth race at the Los Angeles County Fair on Wednesday, September 15, 2010, is suspended THREE (3) racing days (September 22, 23, and 24, 2010) for crossing over without sufficient clearance in the stretch and causing interference, a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of suspension shall not prohibit participation in designated races in California.

The above ruling was issued to Jockey ALEX JIMENEZ for drifting in several paths inside the 1/16 pole approaching the finish line, the first time around in the 1-1/16 fifth race. This action put the horse to his inside on his heels and in a precarious position. Mr. JIMENEZ told the Stewards that he should have waited a few strides more before he came over.

9/16/10⁶ **FIRST RACE – NO SHOW WAGERING – MULES**

Today's first event is for Mules at 350 yards and will not offer Show wagering due to a prohibitive favorite possibly causing a large minus pool. This request was granted by the California Horse Racing Board.

9/16/10⁷ **INQUIRY – NINTH RACE – NO CHANGE**

The Stewards posted the inquiry sign following the running of the ninth race (six furlongs) to review an incident just past the 1/8 pole, involving #2 PRECIOUS SONG (4th - J Gihua) drifting in and interfering with #7 DOS VEINTE (3rd – A. Quinonez).

After a review of the taped replay, the Stewards ruled unanimously that there be no change to the original order of finish, as #2 finished behind #7, with whom he had interfered. Apprentice Jockey JOHNNY GIHUA will be in to see the Stewards tomorrow to review his ride.

9/17/10²**ENTRIES AND DRAW**

The entries for Wednesday were drawn at 1:00 p.m., resulting in a twelve race program made up of one Mule, one Arabian, and ten Thoroughbred races.

9/17/10³**CAL-BRED REPORT**

There will be no races conducted today exclusively for California-breds.

9/17/10⁴**GIHUA RULING – LAFP #007**

Apprentice Jockey JOHNNY GIHUA, who rode PRECIOUS SONG in the ninth race at the Los Angeles County Fair on Thursday, September 16, 2010, is suspended THREE (3) racing days (September 23, 24, and 25, 2010) for failure to maintain a straight course in the stretch and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued to apprentice Jockey JOHNNY GIHUA for failure to maintain a straight course passing the 1/8 pole and causing interference in the ninth race (six furlongs) on Thursday, September 16, 2010, at Fairplex Park. Mr. GIHUA said he first thought his mount took a bad step and would then right herself, but by the time he realized the horse was continuing to come inward, he was too late in trying to straighten her up to avoid the contact with the horse to his inside. There was no change to the order of finish in this race due to Mr. GIHUA's horse finishing behind the horse he bothered.

9/17/10⁵**REQUEST FOR APPRENTICESHIP EXTENSION**

Jockey agent GEORGE ORTUZAR and apprentice Jockey JOHNNY GIHUA were in to see the Stewards to request an extension of his apprenticeship for a period of five (5) days, due to an injury he sustained during morning training hours at the Del Mar meet.

It was also brought to the Stewards' attention that apprentice GIHUA had sustained injuries in two separate incidents in his native country of Peru before arriving in the United States. Regarding the first of these, the Peruvian Jockey Club gave him an extension for approximately six months, which the California Stewards acknowledged. However, the second incident was just now brought to this Board of

Stewards' attention for consideration of an additional two weeks. The Stewards thought there was not enough documentation for this request and that it should have been addressed earlier when he first appeared for his initial licensing.

After a thorough review of all medical and other written documentation, this Board of Stewards decided unanimously to extend the term of apprentice Jockey JOHNNY GIHUA's apprenticeship five (5) days for good cause, reflected in the following ruling:

Apprentice Jockey JOHNNY GIHUA, having supplied medical documentation to verify his request for an extension to his apprentice Jockey's license, is granted an extension of FIVE (5) DAYS. JOHNNY GIHUA's apprenticeship shall terminate on October 1, 2010, at midnight.

9/17/10⁶

RIDERS SEE STEWARDS

Jockey JOSE VERENZUELA appeared as required by the Stewards to address an issue concerning his not calling the Stewards to request permission to be late arriving to the Jockey's quarters for the day's races. Mr. VERENZUELA was advised that he must call each racing day, one hour before post time for the first race, to request such permission. JOSE said he was sorry and didn't understand the rule. A warning was given for this first offense.

Jockey DIHIGI GLADNEY also came in to address two separate issues. The first was his ride in the ninth race on Wednesday when his mount drifted in during the final 1/16 of a mile. DIHIGI acknowledged his miscue and stated he would make a better effort in the future.

The second issued concerned him not appearing the previous day as ordered. DIHIGI said he had major traffic problems and that he just didn't allow the proper time to get here. The Stewards warned DIHIGI that he must be responsible and accountable for his actions. A warning was given not to let this happen again. Mr. GLADNEY got the message.

WIN ONLY WAGERING – FIRST RACE

Today's first race (350 yards – Mule) will offer Win only wagering due to prohibitive favorite SARAH NELSON causing an anticipated large minus pool. This request by Fairplex Park management was granted by the California Horse Racing Board.

9/17/10⁸

INQUIRY/ACCIDENT – FIFTH RACE – NO CHANGE

The inquiry light was lit following the four-furlong fifth race to review an incident leaving the quarter pole where #4 BENEDICTA THE FREE (DNF – F. Valdez) stumbled and unseated Jockey FELIPE VALDEZ. (See attached accident report.)

After a thorough review of the tape replay and speaking to the patrol judges and the rider of #5 LACY BLOOMERS (6th – C. Russell) who was next to #4 when that one went down, the Stewards ruled that there would be no change to the original order of finish as it was determined that #4 was the cause of her own problem by lugging out and apparently stumbling. It was reported that the rider was uninjured and that the horse grabbed its quarter and was otherwise uninjured.

9/17/10⁹ NO SHOW WAGERING – EIGHTH RACE

There was no Show wagering offered on today's eighth race due to CHRB rule #1954 being invoked because the field was reduced from six racing interests to four as a result of two late declarations.
