GLATT RULING

The following ruling was issued after said horse started.

LATS RULING #075

Trainer MARK GLATT is fined FOUR HUNDRED DOLLARS (\$400.00)* for violation of California Horse Racing Board rule #1845 (Authorized Bleeder Medication – late registration of ZORICH in the ninth race at Santa Anita Park on April 7, 2019).

PEREIRA RULING

On Sunday by telephone MR. PEREIRA admitted he over used his crop and the following ruling was issued.

LATS RULING #076

Jockey TIAGO PEREIRA, is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in last 60 days), during the first race at Santa Anita Park on April 7, 2019.

JOCKEY WARNING

VICTOR ESPINOZA met with the Stewards to discuss the reason he couldn't arrive from New York in time to ride yesterday. He stated when he arrived at the airport (JFK) he discovered he would have to unexpectedly check his carry on. This delay caused him to miss his flight. In a majority opinion (Baker dissent) he was issued a warning.

So Ca Equine Foundation, Inc. filed a financial complaint against owners STEFAN & MALLORY KOWALOW in the amount of \$1,820.65 for services rendered. A financial agreement was signed by both parties and the complaint was withdrawn.

Veterinarian John Araujo filed a financial complaint against owner THE ELLWOOD JOHNSTON TRUST in the amount of \$14,211.01 for services rendered. A financial agreement was reached and signed. The complaint was withdrawn.

Jockey's Guild Representative DARRELL HAIRE met with the Stewards to discuss the use of a new crop (360GT) designed by retired jockey Ramon Dominguez. On April 5, 2019 the Jockey's Guild announced by letter a proposal that today's races be performed without the use of a riding crop. Late Wednesday morning (April 10, 2019) the Jockey's Guild withdrew their proposal and the 360GT will be used instead of the cushion crop by all jockeys.
- 04/12/19⁷ **ACCIDENT/NO CHANGE/SECOND RACE 5 1/2 furlongs dirt**
In the stretch run #6 NIGHT AT THE OPERA (Eswan Flores) fell and unseated the jockey. The Racing Veterinarian and the Paramedics were on scene immediately. The horse got up on its own and it was reported to be fatigued, there were no injuries. The jockey was transported to First Aid to be evaluated and was cleared to ride.

MILLER RULING

The following ruling was issued after MR. MILLER decided to not to run his entrant. His decision involved CHRB rule 1634 (Claiming Option Entry). The issue being, Mr. Miller stated, when he entered the horse he opted for the horse to be 'ineligible' to be claimed due to the fact it had been laid off for more than 180 days. The Racing Official that took the entry stated Mr. Miller did not opt for the horse to be 'ineligible' to race with a claiming price. Per the rule (1634) the problem cannot be remedied, thus Mr. Miller chose to not run his horse.

LATS RULING #077

Trainer PETER MILLER, who was scheduled to start RIVER ECHO (GB) in the fourth race on April 14, 2019, at Santa Anita Park, is fined FOUR HUNDRED DOLLARS (\$400.00)* for violation of California Horse Racing Board rule #1629 (Penalty for Late Declaration – trainer decision).
