FILM REVIEW

Apprentice Jockey RUBEN FUENTES came to the office to review his ride in the fourth race yesterday during which his mount drifted out during the stretch run. Mr. Fuentes explained that his horse was trying to get out the entire race and his arm was tired by the time he reached the stretch. He further stated that he tried to keep his horse straight while he also tried to win the race. The majority believed that he could have made more of an effort which constituted careless riding, and therefore issued a three day suspension. Steward Chaney believed that the riding was sloppy but not careless and therefore voted for a warning.

LATS Ruling #086

Apprentice Jockey RUBEN FUENTES, who rode TALLY MO in the fourth race at Santa Anita Park on March 5, 2017 is suspended for THREE (3) racing days (March 19, 23 and 24, 2017) for failure to make the proper effort to maintain a straight course and causing interference in the stretch. This constitutes a violation of California Horse Racing Board rule 1699 (Riding Rule – Careless Riding).

Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

FRIDAY3/10/17¹**REVIEW**

Jockey NORBERTO ARROYO came to the office to review his ride in the eighth race on Sunday. Specifically we believed that he could have made a better effort for fourth place. He explained that his horse was briefly shut off and that the horse didn’t feel that good, so he was doing the best he could to save the position and protect the other participants. We explained that it is better to either ride to the wire or pull up his mount, rather than to try to do both. He agreed. Warning. He was fined however for missing film review yesterday:

LATS Ruling #087

Jockey NORBERTO ARROYO, JR. is fined FIFTY DOLLARS (\$50.00)* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to attend film review on March 9, 2017).

Jockey Agent NELSON ARROYO was fined for failing to make a rider change in a timely manner yesterday:

LATS Ruling #088

Agent NELSON ARROYO is fined TWO HUNDRED DOLLARS (\$200.00)* for violation of Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations – failure to conduct business in a proper manner on March 8, 2017 at Santa Anita Park).

3/10/17³**ORANTES RULING**

We held a disorderly conduct hearing (fighting) in December regarding Pony Rider WILVER ORANTES but withheld judgment until the criminal hearing was completed. Mr. Orantes received deferred judgment with anger management, restitution and community service. We issued the following ruling:

LATS Ruling #089

Pony Rider WILVER ORANTES is fined THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule #1874 (Disorderly Conduct – fighting in stable area while on horseback) on October 14, 2016 at Santa Anita Park.

SATURDAY3/11/17¹**FILM REVIEW**

Jockey TYLER BAZE called yesterday and prospectively accepted any penalty we issue after review of his whip use in the fourth race. After viewing the video, we issued the following penalty:

LATS Ruling #090

Jockey TYLER BAZE is fined FIVE HUNDRED DOLLARS (\$500.00)* for two (2) violations of California Horse Racing Board rule 1688 (b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – second and third offenses in last 60 days), during the fourth race at Santa Anita Park on March 10, 2017 (last offense on February 11, 2017).

3/11/17²**LEYTE RULING**

The following ruling was published after we discovered an error in the original ruling:

LATS RULING #082 (AMENDED)

Exercise Rider GUADALUPE LEYTE is suspended for THIRTY (30) calendar days from March 13 through April 11, 2017 for violation of California Horse Racing Board rule #1690 (Prohibited Equipment – Exercising Horse with Spurs).

Furthermore the TWENTY (20) day suspension stayed in LATS Ruling #20 (January 24,) will now be enforced, as stated in that ruling, due to a second offense related to Animal Welfare. These suspension days are April 12, 2017 through May 1, 2017.

Mr. LEYTE shall remain on probation for as long as he holds a license from the California Horse Racing Board.

Jockey TYLER BAZE came to the office as directed to review his crop use in the eleventh race yesterday. After discussing the race with us and a reiteration of the rule (he was fined yesterday for the same infraction), he accepted the following penalty:

LATS Ruling #092

Jockey TYLER BAZE is fined FOUR HUNDRED DOLLARS (\$400.00)* for violation of California Horse Racing Board rule 1688 (b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – fourth offense in last 60 days), during the eleventh race at Santa Anita Park on March 11, 2017 (last offenses (2) on March 10, 2017 and (1) on February 11, 2017).

3/12/17²**ARROYO RULING**

Jockey NORBERTO ARROYO telephoned this Board as directed and accepted responsibility for falsifying the jockey sign in sheet with respect to his arrival time yesterday. He did so because he was past the hour required to be present before one’s starting time. For those two infractions, he was issued the following ruling:

Jockey NORBERTO ARROYO, JR. is fined TWO HUNDRED DOLLARS (\$200.00)* for violation of California Horse Racing Board rule #1680 (Jockeys and Drivers to Report) on March 11, 2017 at Santa Anita Park.
