DESORMEAUX RULING

As memorialized in the following ruling, Mr. DESORMEAUX was penalized for missing his mount when he informed the Stewards Sunday morning he would not return from Kentucky in time to ride.

LATS #130

Jockey KENT DESORMEAUX, who was scheduled to ride #1 TATTENHAM in the ninth race on May 8, 2016, at Santa Anita Park is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

STEVENS RULING

The following ruling was issued after GARY STEVENS accepted the penalty. He stated he has been riding in Kentucky and upon his return to California he forgot about the crop rule.

LATS #131

Jockey GARY STEVENS is fined ONE HUNDRED DOLLARS (\$100.00)* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense), during the first race at Santa Anita Race Track on May 8, 2016.

MIYADI CONFERENCE CALL - CASE # 15LT028

The Pre-hearing conference call with trainer STEVE MIYADI's counsel DARRELL VIENNA and VANESSA MARTINEZ from the Deputy Attorney's office informed the BOS they were very close to an agreement on a settlement for the medication violation of the Class I drug, amphetamine and methamphetamine found in one of Mr. Miyadi's runners. Due to the approval needed from the Board in Sacramento another conference call is scheduled in two weeks on May 26, 2016, at 11:30 a.m. The disqualification ruling was issued on April 8, 2016, Ref 4/17/16⁴ and 4/8/16⁷.

5/12/16⁴**JOCKEY FILM REVIEW**

Apprentice jockey BRUNO PANICUCCI met with the Stewards to review the third race on Sunday in which he violated the crop rule. He accepted the penalty and the following ruling was issued:

LATS #132

Apprentice Jockey BRUNO PANICUCCI is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – second offense in the last sixty days; last offense April 30, 2016), during the third race at Santa Anita on May 8, 2016.

Jockey ROIMES CHIRINOS met with the BOS this morning to be licensed in the state of California. He is originally from and rode in Venezuela. His license record shows he was licensed in the United States as early as 2004. His RCI printout verified he has been licensed as a jockey in ten other states. His agent is NELSON ARROYO.

FLAVIEN PRAT met with the Stewards to review the run into the first turn in the third race yesterday. After watching the angles available it was agreed by all the blame for the confusion that occurred was placed on the horse and not the jockey; warning.

HENDRICKS FORMAL HEARING - CASE 16SA0042

A complaint filed by the CHRB against trainer DAN HENDRICKS involving CHRB rule #1588 (g) (Horse Ineligible to Start in a Race) pursuant to rules #1752 (c) (Grounds for Objection), #1592 (Ineligible Horse to Be Disqualified) and rule #1634 (Claiming Option Entry). This filing involves the eligibility of one of Mr. Hendricks' trainees who won a starter allowance race for which it was possibly ineligible. All owners that participated in the race in question were notified of the hearing; none appeared. Present at the hearing

before the BOS, representing the CHRB, Investigator PHILIP MIYAZAKI who presented information in the case and recording the proceedings, court reporter MICHELLE DERIEG. Along with trainer Dan Hendricks was his counsel DARREL VIENNA, who also is representing owner, Sheehy LLC.

The facts discussed were as follows:

1. The horse CHINA GIRL LOVER ran and won the fifth race at Santa Anita on February 7, 2016.
2. The next day the Stewards were informed CHINA GIRL LOVER might not have been eligible for the race.
3. The condition for the race reads as follows: "For four years-old and upward which have started for a claiming price of \$25,000 or less in 2015-2016."
4. CHINA GIRL LOVER competed for the claiming price of \$16,000.00 on July 24, 2014.
5. CHINA GIRL LOVER competed in a claiming race (\$16,000.00) on August 1, 2015 but opted to not run for the claiming price pursuant to CHRB rule #1634 (Claiming Option Entry).
6. Defense opinion: When CHINA GIRL LOVER started in the claiming race (\$16,000) and opted out of being eligible to be claimed [rule #1634(a)(2)], qualified its eligibility for the Starter Allowance race in question.

After entering all documents into the record the hearing was closed. Decision to follow.

INQUIRY - NO CHANGE - FOURTH RACE (five furlongs-dirt)

Following the running of the race the Inquiry sign was posted to review an incident in the stretch involving #3 AIKAU (V. Bednar, 3rd), #7 TEMPLAR (M. Pedroza, 6th) and #8 OUTTHINK'EM (J. Verenzuela, 1st). Inside the 1/16 marker, #7 stepped out slightly as #3 was trying to run up between that one and #8; #3 had to check slightly. In a unanimous decision a disqualification was moot as #3 beat #7. The original order of finish was made official.

INQUIRY - DISQUALIFICATION - FOURTH RACE - 6 1/2 turf

Following the running of the race the Inquiry sign was posted to review an incident during the transition crossing the dirt. Involved were #2 ESPIRITO BUENO (B. Boulanger, 1st) and #5 SEEDSANDSTEMSAGAIN (S. Gomez, 2nd). #2 in front, jumped crossing onto the dirt and bore out several paths carrying #5 out with it. The margin of victory was a nose. In a unanimous decision the BOS felt #5 was cost the opportunity of a better placing and #2 was disqualified and placed second, behind #5.
