We issued the following ruling this morning:

Jockey FERNANDO PEREZ is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days; last offense August 19, 2015), during the eighth race at Los Alamitos Thoroughbred Winter Meet on December 20, 2015.

Dr. MELINDA BLUE appeared in support of the financial complaint (case number 15LT027) she filed against trainer MICHAEL PENDER alleging unpaid vet bills. They came to an agreement before the hearing which we memorialized in a written document.

Following the running of the third race, we posted the Inquiry to examine the start of #5 C J KNOWS BEST (F. Perez), who left the gate slowly. Films revealed that the horse broke inwardly, and either stumbled or clipped heels. Since the horse caused its own issues, a change was not appropriate.

IN HOUSE MEETING

Sunday afternoon VP Racing/Racing Secretary RICK HAMMERLE requested a meeting in the Stewards' office this morning. Included were Santa Anita Senior Vice President JOE MORRIS, Racing Director MIKE LAKOW, Mutual Manager RANDY HARTZELL, Safety Steward LUIS JAUREGUI and Paddock Judge KAREN DENOVEL. Management wanted to discuss the length of post times and parades. With the Stewards' office as their forum, management discussed how they can create consistency in the length of the on track parades. They were made aware of CHRB rule #1695 (To the Post) which states not more than twelve minutes will be consumed in the parade of the horses to the post except in cases of unavoidable delay. This gave management a guideline to sort out their issues and the meeting was adjourned.

JOCKEY FILM REVIEW

DRAYDEN VAN DYKE met with the Stewards to review the second race Sunday in which he possibly caused an outward float coming off the second turn in the one mile event. After a review it was agreed that although Van Dyke shifted out, the horse to his outside drifted out also floating the horse to its outside. No contact was made. Mr. Van Dyke was instructed that he moved early and in the future to be more patient. He agreed.

RAFAEL BEJARANO also was in to review the fifth and eighth races in which his mounts drifted and his efforts to correct were minimal. He was warned this BOS expects a stronger attempt to correct; he agreed.

DAMORE RULING – LATS #002

Mr. DAMORE was penalized after confirmation from Senior Outrider JOHN CORTEZ that he was galloping near the quarter pole on the rail; two horses working behind him had to veer to either side of his horse to continue their workout.

Exercise rider LOUIS DAMORE is fined FIFTY DOLLARS (\$50.00) for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – outrider – galloping on rail).

The following ruling was issued after Mr. GONZALEZ met with the Stewards to review the first race Sunday. He whipped his horse four consecutive times without giving his mount a chance to respond two full strides between whips.

Jockey SANTIAGO GONZALEZ is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the first race at Santa Anita Race Track on December 27, 2015.

INQUIRY - SECOND RACE - NO CHANGE (7/8 dirt)

Following the running of the race, the Inquiry sign was posted to review an incident in mid-stretch. Involved were #3 PARALYZING EYES (G. Nicolas 4th), #4 SAILOR'S CRY (J. Verenzuela, 3rd) and #5 SEATALPHA (T. Pereira 5th). After a review of the video, conversation with Patrol Judges and all jockeys involved, in a unanimous decision to make no change, the race was made official. In the opinion of the BOS, even though #5 steadied approaching the two horses in front of him, the hole between #3 and #4 closed before it was reached.

The following ruling was published after the California Horse Racing Board adopted the proposed decision and remanded it back to the BOS to write the ruling.

The Proposed Decision, having been adopted by the California Horse Racing Board, TIM YAKTEEN, trainer of the horse BIG BOOK, the first place finisher in the third race at Del Mar Thoroughbred Club on July 25, 2015, is fined THREE THOUSAND DOLLARS (\$3,000.00) and suspended for SEVEN (7) DAYS (January 11 through January 17, 2016), pursuant to California Horse Racing Board Rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board Rule #1843(d) (Medication, Drugs and Other Substances – 2-(1hydroxyethyl) promazine sulfoxide – Class 3 – in excess of permitted levels).

During the term of suspension, all licenses and license privileges of TIM YAKTEEN are suspended. Mr. YAKTEEN is prohibited from entering horses during the term of suspension and pursuant to California Horse Racing Board Rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. YAKTEEN is denied access to all premises in this jurisdiction.

RAFAEL BEJARANO met with the Stewards to review the use of his whip in the third and seventh races. Mr. Bejarano agreed that in the third race he whipped his horse more than three times consecutively in the stretch run. In the seventh race, in mid-stretch his horse was lugging in while racing on the fence. After a review of the video Mr. Bejarano admitted he did use the whip left-handed once on his horse's nose and stated he did it for safety reasons. This BOS felt his horse responded when he used his reins to guide it and his use of the whip was not necessary. The following two rulings were issued

Jockey RAFAEL BEJARANO is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the third race at Santa Anita Race Track on December 31, 2015.

LATS #006

Jockey RAFAEL BEJARANO who rode IMPERIOUS ONE (IRE) in the seventh race on December 31, 2015, at Santa Anita Race Track, is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1688 (Use of Whips – misuse).

Following the running of the second race the Stewards had Announcer FRANK MIRAMAHI announce there would be a Stewards' Review of two incidents involving #2

RASTANORA and #3 SEND ME A SIGN who were pulled up after going wrong. After a review of the videos it was a unanimous decision that no other horses were involved in the incident and an Inquiry was not necessary. See attached notification reports.
