EXERCISE RIDERS CONFRONTATION

It was reported to the BOS that exercise rider MAXIMO CORRALES and jockey JOEL CRUZ were in an oral and physical altercation while on horses this morning. The two licensees stated they had words at the gap of the main track but did not swing fists at each other. Reports from a Security Guard, a trainer and an assistant trainer refute their testimony. The following rulings were issued:

LATS #126

Exercise rider MAXIMO CORRALES is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct – fighting while on horseback).

LATS #127

Exercise rider JOEL CRUZ is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct – fighting while on horseback).

5/31/15³**FILM REVIEW (Ref 5/25/15³)**

Jockey MIKE SMITH met with the Stewards to review a race on Monday, 5/25/15, after which his mount was disqualified. After a review of several angles of the incident, it was a unanimous decision that the movement from Smith's horse that resulted in the majority decision to disqualify was not due to careless riding. He left the office with a warning.

5/31/15⁴**VOIDED CLAIM**

After an inspection by Official Veterinarian TIM GRANDE, CITY CHAPEL trained by RICHARD BALTAS in the fifth race was placed on the Veterinarian's List and the claim was **VOIDED**.

6/04/15²**CAMACHO RULING – LATS #121 (Ref 5/21/15³)**

The following ruling was issued after Mr. Camacho was informed of the decision:

Association Employee JESUS CAMACHO is fined FIVE HUNDRED DOLLARS (\$500.00) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct –schooling his horse between races).

6/04/15³**GARCIA RULING – LATS #128**

Pony rider PEDRO GARCIA is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations – leaving mark with spur during warm-up period for the 5th race, May 23, 2015).

The above ruling was issued after an informal hearing was held. Mr. GARCIA spurred a race horse while warming up in the post parade. It was reported to the Stewards and was given to Safety Steward LUIS JAUREGUI who took a picture of the horse in question. Mr. Garcia did not own up to the offense and stated he did not wear spurs. After seeing the video of himself wearing spurs during the race warm-up in question, he accepted responsibility.

6/04/15⁴**LOPEZ RULING - LATS #129**

The following ruling was issued after an informal hearing with Mr. LOPEZ. He humbly stated he was wrong, apologized and accepted the penalty:

Jockey WILLY LOPEZ is fined FIFTY DOLLARS(\$50.00) for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – backtracking in front of starting gate in contradiction of track safety rules).

6/04/15⁵**PONY WELFARE MEETING**

A meeting was held with the BOS. In attendance were: Commissioner MADELINE AUERBACH, Equine Medical Director RICK ARTHUR, Safety Steward LUIS JAUREGUI and by telephone Executive Director RICK BAEDEKER. The issue of concern was the welfare of the pony horses used in the industry and how California can be in the forefront of implementing procedures for the care and benefit of the animals. Several policies have already been put into place. The CTT will be contacted and brought on board as well. There will be a Safety meeting June 7, 2015, and during that time all pony riders will be briefed on what is expected from them and the care of their horses.

After an inspection by Official Veterinarian TIM GRANDE, #3 PAX TECUM who raced in the third race was placed on the Veterinarian's List and the claim was **VOIDED**. The horse returned to the stable of DAVID HOFMANS.

FRIDAY6/05/15¹**BLAKE HEARING - CASE #15SA0153**

A financial complaint (CHRB rule 1876) was filed for Veterinarian NOLTON PATTIO against trainer BLAKE KELLY in the amount of \$4,552.00. Mr. Kelly did pay \$552.00, and once a financial agreement for the remaining amount is signed by both parties the case will be withdrawn.

6/05/15²**O'HARA CASE #15SA161**

A financial complaint (CHRB rule #1876) was filed for K C HORSE TRANSPORTATION against owner-trainer JOHN O'HARA in the amount of \$755.42. Neither party appeared for the hearing yesterday. Therefore, the case was dismissed.

6/05/15³**O'CALLAGHAN CASE #15SA0181**

A financial complaint (CHRB rule 1876) was filed for ANGEL'S FEEDS, INC. against trainer CARL O'CALLAGHAN, in the amount of \$10,962.94. CHRISTIAN UNAMUNO appeared on behalf of Angels Feed and stated that he last communicated with Mr. O'Callaghan on May 18, 2015. At that time Mr. O'Callaghan said he would send money; this has not transpired. Mr. O'Callaghan failed to contact this BOS or appear for the hearing. Ruling to follow.

6/05/15⁴**SPAWR FORMAL HEARING - CASE #15SA0184**

The CHRB filed a complaint against trainer BILL SPAWR for a possible violation of CHRB rule #1843(a)(d) (Medication, Drugs and Other Substances), #1843.1 (Prohibited Drug Substances), #1844(f)(9) (Authorized Medication) and #1887 (a) (Trainer to Insure Condition of Horse). Recording the proceedings was court reporter MICHELLE DERIEG and representing the CHRB was Investigator PHIL MIYAZAKI. Mr. Spawr was available by telephone and stated the horse trains on Methocarbamol and was taken off the medication three days before the race. His private veterinarian, RYAN CARPENTER, now has advised him to stop the medication 96 hours before race time. The following ruling was issued:

LATS #130

Trainer WILLIAM SPAWR, who started the horse ENDLESS CRUISE which finished first in the seventh race at Santa Anita Park on May 1, 2015, is fined FIVE HUNDRED DOLLARS (\$500.00)* pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1844(F)(9) (Authorized Medication – Methocarbamol in excess of permitted level [3.7 ng/ml]).

6/05/15⁵**VOIDED CLAIM**

After examination by the Official Veterinarian TIM GRANDE, #1 GLADDING, who raced in the eighth race, was placed on the Veterinarian's List and the claim was **VOIDED**. The horse returned to the stable of JOHN SADLER.

6/05/15⁶**ACCIDENT POST RACE**

Pulling up after the eighth race, the winner, #8 LIMITED REASON, stumbled and unseated its jockey ALEX SOLIS. Mr. Solis got up and remounted for the win picture. He was then escorted to First Aid to be evaluated by the track physician. Accident report attached.
