4/2/15²**SANCHEZ FORMAL HEARING - CASE 14LT006**

The Complaint was filed by the CHRB pursuant to CHRB rule #1900 (Grounds for Suspension or Revocation) for an alleged violation of rule #1902.5 (Animal Welfare). Present for the hearing were respondent, assistant trainer JOSE SANCHEZ, his counsel ROGER LICHT, Deputy Attorney General MICHAEL YI, counsel for the CHRB and interpreter ALEX VELASCO. The proceedings were recorded by Court Reporter MICHELLE DERIEG. Witnesses for the CHRB included the previous owner of the horse in question, CELSO MUNOZ, Outrider RUDOLPHO "RUDY" MARQUEZ, Veterinarian JOHN ARAUJO and Investigator JIM HAMILTON. Trainer HECTOR PALMA testified on behalf of respondent JOSE SANCHEZ. Testimony was heard from all the witnesses and documents were submitted into evidence. The hearing will be continued tomorrow due to the lack of time before today's first race. Mr. SANCHEZ will be the last to testify.

After an inspection by Official Veterinarian TIM GRANDE, #2 BADASMYWIFELETSMEB which was claimed from the fourth race was placed on the Veterinarian's List for unsoundness and the claim was voided. The horse returned to the stable of trainer BARRY ABRAMS.

FRIDAY4/3/15¹**COUTON FORMAL HEARING - CASE 14SA225**

A complaint was filed by the CHRB against Jockey JULIEN COUTON for an alleged violation of CHRB rule #1902 (Conduct Detrimental to Horse Racing) pursuant to rule #1900 (Grounds for Suspension or Revocation). In attendance were: DAG ROBERT PETERSON representing the CHRB, the respondent JULIEN COUTON and his counsel SETH WEINSTEIN, character witnesses for the respondent jockey valet MICHEL POINCELET and jockey BRICE BLANC, witness for the complainant Police Officer HENRY WONG (Arcadia Police), and CHRB Supervising Investigator Rick Amieva. Jockeys' Guild Western Regional Manager DARRELL HAIRE was present as an observer as well as *Daily Racing Form* representative STEVE ANDERSON. Court Reporter MICHELLE DERIEG documented the proceedings. Due to time constraints, the hearing was continued to April 12, 2015.

4/3/15²**SANCHEZ FORMAL HEARING CONTINUED - CASE 14LT006 (Ref 4/2/15)**

Upon the return of counselors ROGER LICHT, DAG MICHAEL YI and respondent JOSE SANCHEZ the hearing was conducted with court reporter MICHELLE DERIEG documenting the proceedings. Interpreter ALEX VELASCO translated. Dr. VINCENT BAKER appeared as a witness and testified for the defense. Testimony from JOSE SANCHEZ was heard and Dr. JOHN ARAUJO was recalled by the CHRB. Closing statements were given and the hearing was closed. All exhibits were admitted into evidence. Decision to follow.

The following ruling was issued after Mr. Couton appeared for a scheduled hearing (decision on the underlying complaint will be made after the continuation on April 12, 2015:

Jockey JULIEN COUTON, having appeared to answer case number 14SA225, is reinstated. LATS Ruling #222 dated September 28, 2014, is set aside. As a condition of reinstatement, Mr. COUTON is ordered to stay 100 feet away from the alleged victim and is further ordered to comply with all rules and regulations of the California Horse Racing Board.

4/4/15²**INQUIRY - FIRST RACE - NO CHANGE**

Following the running of the race, the Inquiry sign was posted to review an incident near the eighth pole. Involved were #6 HE WILLIE (E. Trujillo, 1st) and #7 SIR PERSERVERE (F. Prat, 2nd). After conversation with the Patrol Judges and both jockeys involved, in the Stewards' opinion, #6 did duck in causing #7 to shy inward, but the slight shift did not effect the placing of #7 and the race was made official.
