Trainer NEIL DRYSDALE is fined FOUR HUNDRED DOLLARS (\$400)* for violation of California Horse Racing Board rule #1853(b) (1) (Examination Required – failure to report shoeing change at time of entry).

BAZE RULING – LATS #196

We issued the following ruling when jockey TYLER BAZE rode two designated races yesterday during one of his suspension days:

Jockey TYLER BAZE is suspended for ONE (1) additional RACING DAY (June 6, 2014) pursuant to California Horse Racing Board rule #1766 (Designated Races – participated in more than one designated race on May 31, 2014).

Jockey ESWAN FLORES came to the office to review his ride in the last race Friday. Films revealed that he hit his horse 8 times in the stretch but only beat one horse and was 15 lengths behind the next finisher. He explained that he was trying to educate the first time starter. We tried to impart other ways of educating the young horse, and issued the following ruling:

Jockey ESWAN FLORES is fined THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule #1688(b)(4 & 5) (Use of Whips – continuing to use his whip when his mount was clearly out of the race), during the eighth race at Santa Anita Park on May 30, 2014.
