STUTTS RULING – LATS #110 (Ref-03/20/14³)

The following ruling was issued after Mr. STUTTS was informed of his penalty:

Trainer CHARLES STUTTS is fined FIVE HUNDRED DOLLARS (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse), for violation of California Horse Racing Board rules #1843 (Medication, Drugs and Other Substances), and #1844 (Authorized Medication – flunixin in excess of the permitted level – 72 ng/ml in the post- race blood sample of his runner CRIMSON GIANT which finished second in the fifth race at Santa Anita Park on January 10, 2014).

Owner JAMES A. DAVIS, having failed to respond to charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility – Dr. Nolton Pattio - \$2,565.00), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear). During the term of suspension, all licenses and license privileges of JAMES A. DAVIS are suspended and pursuant to California Horse

Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. DAVIS is denied access to all premises in this jurisdiction.

LATS #112

Owner MICHAEL SCOTT DUNCAN, having failed to respond to charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility – Dr. Nolton Pattio - \$635.00), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of MICHAEL SCOTT DUNCAN are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. DUNCAN is denied access to all premises in this jurisdiction.

Exercise rider JOSE OROZCO is fined FIFTY DOLLARS (\$50.00) for violation of California Horse Racing Board rule #1437 (Conditions of a Race Meeting – disobedience to outrider while siren was on).

RITVO HEARING - CASE #14SA076

A complaint was filed against trainer KATHERINE RITVO by the CHRB for Official Veterinarian TIM GRANDE. CHRB rules #1852(Reporting to Receiving Barn) and #1894 (Duties of Trainer) were the possible rule violations. Ms. Ritvo appeared by telephone. The complaint stated Ms. Ritvo's horse MUCHO MACHO MAN was 17 minutes late to the receiving barn on March 8, 2014 for the running of the Santa Anita Handicap. The field was detained in the receiving barn for seven minutes due to the tardiness of Ms. Ritvo's horse. Ms. Ritvo stated she did not hear the call to go to the receiving barn. This was her first offense and she was given a warning and told that next time there would be a monetary penalty.

BLUE RULING - LATS #137- Ref 02/01/14⁵

Veterinarian MELINDA BLUE is fined FIFTEEN HUNDRED DOLLARS (\$1,500.00) and suspended for SEVEN (7) calendar days (April 10, 11, 12, 13, 14, 15, and 16, 2014), for violation of California Horse Racing Board rules #1842 (Veterinarian Report – falsification of report) and #1845(e) (Authorized Bleeder Medication – failure to administer Furosemide).

During the term of suspension, all licenses and license privileges of MELINDA BLUE are suspended and pursuant to California Horse Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Dr. BLUE is denied access to all premises in this jurisdiction.

FILM REVIEW

Jockeys MARIO GUTIERREZ and OMAR BERRIO were in to review the second and third races from yesterday. The Stewards were interested in both of their efforts or possible lack of effort during their race. Mr. Gutierrez, in the second race, was asked about his effort; he stated the horse felt a little off. The horse was examined the next day by Racing Veterinarian Dr. Stead and he confirmed the horse fractured a sesamoid. Mr. Berrio stated his mount in the third race has a very light mouth and that is why the horse threw its head up about ten strides out of the gate going into the first turn while in last position. The riding instructions given by trainer A. C. AVILA were to take the horse back and make a late run. The Stewards reminded both riders of rules 1692 and 1884 when riding a race.

LATE SCRATCH

In the ninth race today, in accordance with the condition book rule "coupled entries" trainer BARRY ABRAMS did not declare a preference when two horses with identical ownership were entered. The Racing Office missed the error at the draw. After the overnight was printed, agent VINCE DE GREGORY informed the Racing Office of the error. The race could not be redrawn. Mr. Abrams chose to scratch #10 LITTLE UNUSUAL and this allowed UNUSUAL STYLE, trained by VLADIMIR CERIN, to draw in and run.

As the field passed the ¼ pole, #3 Russian Silk, ridden by Kayla Stra, fractured both sesamoid bones in the right foreleg and fell. No other horses or riders involved.
