VIDEO REVIEW

Jockey Martin Garcia was in the office this morning to review the ninth race from Saturday (1-1/4 miles on turf), during which his mount drifted in to cause crowding during the early stages of the race. Mr. Garcia acknowledged his mistake, and pledged to be more aware in the future. He did not receive a sanction as the rail setting – 12 feet from the inside running rail- and the fact that the starting gate was angled to the outside complicated the situation.

MEDICATION HEARING

Trainer Oscar Garcia was in the office this morning in response to a complaint filed against him by the Board as his horse, Bench Beauty, showed an overage of Flunixin(Banamine) following a workout for removal from the Veterinarian's List. Mr. Garcia, who has not had a #1844c violation in the past 36 months, admitted that the mistake was totally his fault. He explained that at 4:30 A. M. on the morning the horse was to work, it was his intention to medicate the horse with "Gastrogard" paste, an anti-ulcer medication. Unfortunately he grabbed a tube of Banamine paste and, not noticing his error, gave that to the horse.

Mr. Garcia would have been eligible for a warning had the medication found was Phenylbutazone, but the verbiage in rule #1843.3(Penalties for Medication Violations) limits warnings for category "C" violations to Phenylbutazone overages only. Since this was an overage of Flunixin, a ruling for the violation will be issued this coming Thursday.

RULING LATS #028

Jockey **VICTOR CARRERO** is fined **ONE HUNDRED DOLLARS (\$100.00)*** for violation of California Horse Racing Board rule #1680 (Jockeys and Drivers to Report-failure to request permission to arrive late to jockeys' room). This ruling was issued after Mr. Carrero acknowledged his mistake of failing to call for permission to be late to the Jockeys' Room. He had received a warning earlier in the meeting.

Jockey Mario Gutierrez was replaced in the eighth race this afternoon as he was performing community service hours and could not get away in time to fulfill his commitment. A replacement rider was named.

RULING LATS #029

Groom **ANTHONY NICOMETO**, having failed to appear to answer a complaint alleging violation of California Horse Racing Board rule #1874(Disorderly Conduct-assault with a deadly weapon), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Anthony Nicometo are suspended and pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Mr. Nicometo is denied access to all premises in this jurisdiction.

This ruling was issued after Mr. Nicometo failed to appear to address a complaint filed against him for violation of California Horse Racing Board rule #1874(Disorderly Conduct). His whereabouts are unknown.

RULING LATS #030

Pursuant to California Horse racing Board rule #1866(d)(Veterinarian's List), trainer **OSCAR GARCIA** is fined **FIVE HUNDRED DOLLARS (\$500.00)*** for violation of California Horse Racing Board rules #1843(a)(d) (Medication, Drugs, and Other Substances) and #1844(c)(2)(Authorized Medication-Flunixin in excess of permitted level-46.1 ng/ml).

The foregoing ruling was issued to finalize the complaint filed against him for an overage of Flunixin.(Ref. 2-10-13³).

RULING LATS #031

Jockey **MARIO GUTIERREZ** is fined **TWO HUNDRED DOLLARS (\$200.00)*** for failure to fulfill his riding engagement in the eighth race at Santa Anita Race

Track on February 10, 2013. This constitutes a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement). The above ruling was issued as Mr. Gutierrez was otherwise occupied on Sunday and missed his only mount of the day.(Ref. 2-10-13⁵)

A financial complaint filed by Bob Hubbard Horse Transportation against owner Vichien Chattong in the amount of \$825.00 was settled for \$716.00 after a review of the billing charges.

LIBERTINI HEARING

A formal hearing for groom Jason Libertini was held this morning with Mr. Libertini testifying by phone from the Phoenix area. Mr. Libertini was originally licensed in January 2011, but after further review it was determined that he was unable to hold a license in this jurisdiction. Mr. Libertini noted his conviction, which made him ineligible for a license, on his application but was nonetheless approved. A hearing was subsequently set but Mr. Libertini did not appear and was suspended. His problem came to light after he was denied a license in Arizona due to the suspension in this jurisdiction. He said has been licensed in several other jurisdictions even after he noted his conviction of the charge of having sex with a minor. He indicated that he has no intention of ever applying for a license in California again but would like his suspension to be lifted here. Since Mr.Libertini did appear, it was decided to issue the following ruling:

LATS #032

After a formal hearing, ruling HRT# # 003 dated April 28, 2011, suspending groom **JASON LIBERTINI**, is set aside. However, pursuant to California Horse Racing Board rule #1902 (Conduct Detrimental to Horse Racing), Mr. Libertini is not eligible to apply for a California Horse Racing Board license.

REFUND

A refund was ordered in the fifth race as #10 Lika flipped during the saddling procedure and was declared on the recommendation of Racing Veterinarian Stead. The refund amounted to \$2,532.79.

REFUND

A refund was ordered in the eighth race as #2 Smart Journey failed to warm up to the satisfaction of Racing Veterinarian Stead and was declared on his advice. The refund from the scratch totaled \$85,923.42.

The horse was declared on the advice of Dr. Grande, with the resulting refund amounting to \$1,785.95

A refund was ordered in the fifth race as #5 Here's Marine flipped during the saddling procedure and was declared after examination by Racing Veterinarian Dana Stead. There was a refund of \$9,772.41 due to the scratch.

02/16/13⁴**MINUS POOL**

A minus pool of \$15,394.15 was created in the seventh race as #8 Del Mar Sunset, the prohibitive favorite at odds of 1-5, finished second.

02/16/13⁵**MINUS POOL**

A second minus pool took place in the ninth race when #5 Lady Katfish, odds-on at 3-5, proved an easy winner. A total of \$1,143.68 was needed to balance.
