FILM REVIEW

Jockey JOE TALAMO came to the office to view his ride in the fourth race yesterday. It was our opinion that his use of the whip was in contravention of the rules. To wit, we felt that he used his whip excessively when his horse was out of contention for a better placing. He explained that he had ridden the horse before, that he was a bit lazy and felt that he had a chance for third in the four horse field. After the race, we asked the CHRB investigators to examine the horse cooling while out at the barn. The investigators did not find evidence of welts or cuts. Nevertheless, Mr. Talamo was fined in the following ruling:

LATS #073

Jockey **JOSEPH TALAMO** is fined **FIVE HUNDRED DOLLARS (\$500.00)*** for violation of California Horse Racing Board rule #1688 (Use of Whips-using whip persistently even though the horse is showing no response) during the running of the fourth race at Santa Anita Park on April 14, 2012.

Jockey JESIERE MEDINA came to the office this morning with representative/translator jockey Edwin Maldonado to review her ride in the ninth race yesterday in which two horses and jockeys fell, and her horse was disqualified. However, given the serious nature of the potential violation, we preferred to engage the use of a court reporter which is required if a penalty longer than a 10 day suspension could be appropriate. Ms. Medina waived her ten day notice and we set the hearing for this Thursday at 11:00 am pending confirmation with the court reporter.

Jockey DAVID FLORES came to the office to review his ride in the fifth race Saturday in which he floated out a bit causing a rival to check briefly. We cautioned him to finesse the move a bit more in the future.

Jockey JESSIE MEDINA came to the office for the formal hearing referenced previously. Present at the hearing were this Board, Ms. Medina, Luis Jaurgeui (who ran the films and helped translate for Ms. Medina) and court reporter Barbara Weinstein. Ms. Medina was sworn in, waived her right to legal counsel and took full responsibility for the incident. Films put the blame on her as she angled her horse toward the inside fence and caused a major wreck in the process. Decision to follow.

The following ruling was issued when owner MARIA HERNANDEZ failed to appear in the office to answer a complaint filed by the CHRB (case number 12SA085) pursuant to drug conviction:

LATS #075

Owner **MARIA HERNANDEZ**, having failed to appear to respond to a complaint alleging violation of California Horse Racing Board rule #1489(h)(Grounds for Denial or Refusal of License) is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Maria Hernandez are suspended and pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Ms. Hernandez is denied access to all premises in this jurisdiction.

During the term of suspension, all licenses and license privileges of Tomas Urbina Jr. are suspended and pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Mr. Urbina Jr. is denied access to all premises in this jurisdiction.

04/20/12²**ACCIDENT/INQUIRY/NO CHANGE**

Following the running of the sixth race, we posted the inquiry sign to examine the circumstances under which #9 Devoted Magic unseated jockey Joel Rosario shortly after leaving the gate. Films revealed that the horse lost his action in the hind end and no other horses were blameworthy. The result was made official with no changes to the original order. Accident report attached.

SATURDAY04/21/12¹**MEDINA RULING**

Pursuant to the Medina hearing described previously, the following ruling was issued:

LATS #084

Jockey **JESIERE MEDINA**, who rode "Whiskey Talks" in the ninth race at Santa Anita Park on April 14, 2012, is suspended for THIRTY (30) RACING DAYS (April 26, 2012, through June 14, 2012) for exhibiting gross carelessness by crossing over without sufficient clearance and causing interference which

resulted in an accident and the disqualification of her mount to unplaced. This constitutes a violation of California Horse Racing Board rule #1699(Riding Rules-Careless Riding).

During the term of suspension, Ms. Medina is not accorded the privilege of participating in Designated Races pursuant to California Horse Racing Board rule #1766(b)(Designated Races-suspension in excess of ten (10) days).

VALENZUELA MEETING

We met with jockey PATRICK VALENZUELA this morning to discuss a few issues before his comeback ride at Hollywood Park next week. His license is currently in good standing but we wanted to discuss the fact that he remains on a conditional license agreement. His weight and nutrition were also discussed. After the meeting he was directed to the CHRB investigative staff for testing.

INQUIRY/NO CHANGE

We posted the inquiry after the running of the seventh race to look at some bumping between the first two finishers during the stretch run. The winner , #11 Dress Code ridden by Rafael Bejarano, and the second place finisher #9 Let's Do It ridden by Eswan Flores, made mutual contact down the lane. Films showed that the second place finisher was somewhat more culpable and therefore no change was the unanimous decision.

FILM REVIEW

Jockey DANIEL VERGARA came into the office as directed to review his ride in the sixth race Thursday in which he finished second but wanted to claim foul against a rival that finished behind him. We first explained how claiming foul works, and then pointed out that there was an incident going into the first turn but that the blameworthy horse was not the horse he thought it was. We also cautioned him against aggressive riding used to correct perceived infractions. He got the point.

Jockey OMAR BERRIO came to the office to review his ride in the last race on Friday aboard a horse called TORNADO ALLIE trained by AC Avila. We felt that the ride could have been construed as a failure to give his best efforts. The horse broke from the gate, Mr. Berrio took her back and never let her run, eventually pulling her up past the wire. Mr. Berrio claimed that she did feel that great in her hind quarters. While she did sort of sit down in the paddock, according to the racing veterinarian, had just come off of the Vet's list and was put back on the list after this race, we were nevertheless skeptical. There was not sufficient evidence of a rule violation, but we wanted Mr. Berrio to know that we are monitoring these things and therefore take them quite seriously.
