Films showed that jockey Corey Nakatani aboard the eventual winner #6 Macias put pressure on the two horses to his inside causing both to check as the field entered the left hand turn. Both riders claimed foul. After reviewing the films, we unanimously voted to make no change to the original order of finish because we believed that the two horses affected did not lose the opportunity at a better placing.
