Trainer KATHY WALSH and professional gambler JIMMY ALLARD came to the office this morning to express concern that Ms. Walsh's horse, who broke through the gate yesterday, was not examined by the racing veterinarian and permitted to run. The horse had pushed the doors open with some force but was never released by the assistant starter. The doors were quickly closed and the field dispatched. Apparently, the horse lost a couple of teeth in the process and did not run its best race. We agree with their concerns and will put together a meeting to address this situation.

Jockey RAFAEL BEJARANO came to the office as directed to learn the proper procedure for taking off of mounts due to health reasons. Mr. Bejarano, after informing us that he was not well midway through the card yesterday, neglected to see the track physician to finalize his excusal. He now knows the procedure.

STARTER MEETING

Prompted by our meeting with trainer Kathy Walsh on Sunday, we called a meeting to clarify the procedure with respect to horses breaking through the gate. Present at the meeting were Safety Steward Luis Jauregui, Starter Jay Slender, Official Veterinarian Jill Bailey, Racing Veterinarian Dana Stead, Racing Veterinarian Tim Grande, and Director of Racing Mike Harlow. We discussed the incident specifically and generally in order to come up with a policy going forward. While stopping short of automatically scratching horses that break through the gate, we decided that the veterinarian will look at every horse that opens the gate in any way. This will not only provide safety for horses and riders but will also protect the wagering public by providing some opportunity to change wagers if necessary.

GOMEZ WARNING

Jockey GARRETT GOMEZ came to the office as directed to review procedures for requesting removal from his mounts during the card for health reasons. After requesting removal from his remaining mount for illness, Mr. Gomez neglected to see the track physician for examination and approval. We reviewed the proper procedures, and despite his status as a journeyman rider, he now seems to understand.

02/03/10³

INQUIRY/OBJECTION/NO CHANGE

We posted the inquiry sign following the running of the second race to examine an incident in which #5 All Star Heart fell at the quarter pole on the turf course. In addition, jockey Kayla Stra, on third place finisher #4 Tapit So Lightly, claimed foul against the second place finisher for interference nearing the wire. The inquiry was adjudicated quickly when it became clear the #5 All Star Heart slipped on her own and that no other horses were involved. The horse was caught by the outriders and appeared uninjured whereas jockey Brice Blanc was body sore and was excused from his remaining mount. (See attached accident report). With respect to the objection, it was our belief that while the second place finisher did drift out and into the path of Ms. Stra's mount, it happened so close to the finish that she was not cost the opportunity at a better placing. Therefore, no change was appropriate.

FILM REVIEW

Jockey EDWIN MALDONADO came to the office this morning to review an incident in the second race yesterday which prompted jockey Kayla Stra to claim foul against Mr. Maldonado and his mount for interference nearing the wire. Films revealed that that his mount does drift out nearing the wire. While the drift was significant, the interference was minimal and Mr. Maldonado was using his right handed whip. We cautioned him that he must keep a straight course and that he has been to the office too many times this meeting. He seemed to understand and was pleased with a warning.

MUELLER HEARING

Dr. Jeff Blea appeared in the office in support of his practice's complaint against owner DAVID MUELLER alleging violation of CHRB 1876 (Financial Responsibility) which centered around unpaid veterinary bills (case number 11SA022) in the amount of \$6,178.00. Mr. Mueller did not appear. A ruling will most likely be published tomorrow.

OBJECTION/NO CHANGE

Following the running of the seventh race, jockey Patrick Valenzuela, who finished fourth aboard #3 Sayif (IRE), claimed foul against the winner for interference going into the first turn (right handed) on the hillside turf course. The new, temporary,

hand-held, head-on camera angle was extremely helpful in making an informed decision. Mr. Valenzuela alleged that the winner came out going into the turn and caused him to check. Films revealed that it was actually fifth place finisher #2 Matto Mondo (CHI), ridden by Mike Smith, drifting in that caused the interference. Since Mr. Valenzuela's mount finished in front of the interferer, no change was necessary.

During the term of suspension, all licenses and license privileges of David Lyn Mueller are suspended pursuant to California Horse Racing Board rule #1528(Jurisdiction of Stewards to Suspend or Fine), Mr. Mueller is denied access to all premises in this jurisdiction.

FILM REVIEW

Jockey MIKE SMITH came to the office this morning as directed to discuss his ride in the seventh race yesterday in which we felt his horse caused some interference going into the first turn on the hillside turf course. Films revealed that although he did tighten the space on fellow rider Patrick Valenzuela also indicated that his horse was difficult to control and that Mr. Valenzuela had positioned his horse in a less than ideal spot. Mr. Smith was therefore issued a warning.
