Jill Bailey DVM representing the CHRB, Darrell Haire present for the Jockeys Guild, Stewards Tom Ward, Scott Chaney, Kim Sawyer and Safety Steward Luis Jauregui. The colony was informed that although the soft whip is being mandated, any marks in the wrong area will be an issue and safety is always first when aggressive riding is involved. The riding colony was made aware Dr. Stead will be the track Veterinarian on duty the rest of the meet.

After the running of the race jockey Martin Pedroza aboard #3 Red Door Drive who finished second lodged a claim of foul against # 6 Spartan Jet (1st A Delgadillo) for a possible infraction just inside the 3/16 marker. After a review of the films and conversation with the Patrol Judges and both riders, it was the opinion of the Stewards that although #6 did drift out in front of #3, there was sufficient clearance during the drift.
