Trainer BARRY ABRAMS is fined FIVE HUNDRED DOLLARS* (\$500.00) for failure to properly report the gelding of the horse ORBITS WORLD, which ran in the ninth race at Santa Anita Park on February 16, 2008. This constitutes a violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse).

This ruling was issued after the trainer accepted responsibility for failing to report the gelding of the horse Orbits World, which was entered in the ninth race at Santa Anita on February 16, 2008.

02/27/08³**REFUND**

A refund was ordered in the fifth race as #1 Higher Point flipped and became cast in the starting gate, prompting Racing Veterinarian Bailey to recommend that the horse be declared. The refund amounted to \$81,179.17. Jockey Gerry Olguin was not injured.

During the term of this suspension, all licenses and license privileges of Mr. Parker are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), subject is denied access to all premises in this jurisdiction.

This ruling was issued after Mr. Parker failed to appear to address a financial complaint filed against him.

Trainer CLIFFORD SISE, JR., who started the horse "Tropical Bid" which finished second in the fifth race at Santa Anita Park on January 18, 2008, is fined SEVEN HUNDRED FIFTY DOLLARS* (\$750.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (A) (D) (Medication, Drugs and Other Substances – Phenylbutazone, Second Offense).

The foregoing ruling was issued after Mr. Sise telephonically responded to a complaint filed against him for a Phenylbutazone overage. Sise had no explanation for the results.

LATS #143

Trainer SUZANNE RODRIGUEZ, having complied with the provisions of California Horse Racing Board rule #1876 (Financial Responsibility) is restored to good standing. LATC ruling #100, issued at Santa Anita Park on February 2, 2008, for failure to appear, is set aside.

The preceding ruling was issued after Timphony responded via telephone. His case has been remanded for lack of a record and will be re-scheduled.

The Stewards ordered a refund in the first race as #4 Refusal was off in the hind quarters during warm up and was declared on the advice of Racing Veterinarian Jill Bailey. The refund amounted to \$16,412.90.

Owner/Trainer JUAN REVIRIEGO is fined THREE HUNDRED DOLLARS* (\$300.00) for violation of California Horse Racing Board rule #1845 (a) (Authorized Bleeder Medication) at Santa Anita Park on February 29, 2008.

This ruling was issued after the trainer accepted full responsibility for failing to register the horse as a bleeder at the proper time.

02/29/08³**RULING****LATS #147**

Trainer CAESAR DOMINGUEZ is fined FIVE HUNDRED DOLLARS* (\$500.00) for failure to properly report the gelding of the horse Prince Meyer, which ran in the third race at Santa Anita Park on February 15, 2008. This constitutes a violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse).

This ruling was issued after Mr. Dominguez appeared to address a complaint filed against him for failing to report the gelding of his horse, Prince Meyer. The trainer thought he had reported the change when he entered, but accepted responsibility.

02/29/08⁴**REFUND**

A refund was ordered in the first race as #1 Oh I Tripped flipped and became cast under the starting gate, prompting Racing Veterinarian Bailey to recommend a scratch. The refund amounted to \$62,309.96. The rider, Alonso Quinonez, was not injured. The horse, however, was found to have suffered a spinal injury and was euthanized by trainer Anthony Saavedra's attending veterinarian the following day.

03/02/08³**JOCKEY OBJECTION – NO CHANGE**

The objection sign was posted after the seventh race as Alex Solis (2nd, #8 Nerinx) lodged a claim of foul against Saul Arias (1st, #1 Indian Weaver) for interference through the final 1/8th. Solis felt that he and his mount had been forced off of their path when the winner drifted out.

After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing tapes of the stretch run, the Stewards unanimously voted to dismiss the objection. While there was a slight drift by the winner, it was obvious that Solis's chances were not compromised.

This ruling was issued after the owner failed to appear to respond to charges alleging a past due bill to H.E. "Tex" Sutton Forwarding Company.

Owner SALAH AL-MUDARRIS, having failed to appear before the Board of Stewards to answer a complaint alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility) is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of this suspension, all licenses and license privileges of Salah Al-Mudarris are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Salah Al-Mudarris is denied access to all premises in this jurisdiction.

The preceding ruling was issued after the owner failed to appear regarding a delinquent veterinarian bill.

LATS #150

In the Matter of: Groom Fred Peterson

Case #08SA062 having been remanded to the Board of Stewards for a formal hearing, and that hearing having been held on February 24, 2008, it is the decision of the Board of Stewards that ruling #LATS102, issued on February 02, 2008, be affirmed. The new dates of suspension shall be March 10, 2008 through March 23, 2008.

During the term of this suspension, all licenses and license privileges of Fred Peterson are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued after a formal hearing into a complaint filed against Mr. Peterson for a moral turpitude issue. The case was originally heard in early February, but was remanded back to the Stewards for lack of a record.

The facts of the case changed as this time Mr. Peterson said he had no memory of what had occurred. Present at this hearing was Stable Area Security Officer Carlos Eduarte, who testified as to what he observed in a stable area rest room on the night of the violation.

Stewards Christiansen and Ward felt the same penalty was in order, that being a two week suspension. Steward Chaney dissented, stating that while he felt a violation had occurred, the punishment did not fit the crime. He was of the opinion that a fine was in order.
