Saturday09-27-08¹**PRE- MEET DUTIES**

Steward **Paul Nicolo** attended entries, scratches and general morning duties for the three days prior to Wednesday's opening day.

09-27-08²**ENTRIES**

Wednesday's opening day entries were drawn and completed by 1:00 p.m. The ten race card will consist of seven Thoroughbred, a mule, Quarter Horse and Arabian races.

09-27-08³**CAL-BRED REPORT**

The ninth race in the book for Cal-Bred, fillies and mares, was called off with three entries for opening day.

Sunday09-28-08¹ **SCRATCHES and CHANGES**

There were no scratches and only two rider changes carried out at the 9:00 a.m. scratch time.

09-28-08² **ENTRIES**

Entries for Thursday's card were drawn and completed by 12:30 p.m. and consists of seven Thoroughbred and three emerging breed races.

09-28-08³ **CAL-BRED REPORT**

The eighth race in the book for Cal-Breds failed to fill for October 2, 2008.

Monday09-29-08¹ **SCRATCHES and CHANGES**

Scratch time for Thursday was conducted at 9:00 a.m. and produced one scratch and five rider changes.

09-29-08² **ENTRIES**

Nine races are scheduled for Friday's card and feature two mule, one Quarter Horse and six Thoroughbred races.

Wednesday10-01-08¹ **OPENING DAY**

The full Board of Stewards was in attendance as was the California Horse Racing Board licensing and investigative personnel.

The Big Fresno Fair kicks off its 2008 Race Meet this afternoon. Racing Secretary **Tom Doutrich** has ten races with large competitive fields for the opener. First race post time is 1:15 p.m.

10-01-08² **SCRATCHES and CHANGES**

Scratch time for Friday was conducted at 9:00 a.m. and consisted of one scratch and ten rider changes.

10-01-08³ **ENTRIES**

Entries for Saturday were drawn and completed by 12:30 p.m. Saturday's ten race card will have three emerging breeds and seven Thoroughbreds running.

10-01-08⁴ **CAL-BRED REPORT**

The X-5 race for Cal-Breds three year olds failed to fill for October 4, 2008.

10-01-08⁵ **RIDER EXCUSED**

Jockey **Alfredo Miranda**, who suffered an injury during morning workouts, was taken off his mounts for this afternoon and Thursday.

10-01-08⁶ **STAND VISITOR**

California Horse Racing Board Vice-Chairman John Harris, who attended opening day, stopped by the stewards' stand this afternoon.

10-01-08⁷ **INQUIRY – DOUBLE DISQUALIFICATION – Second Race**

The inquiry sign was posted for two incidents that occurred during the running of the second race. The first incident involved the fourth and fifth place finishers. The films show #5 SOFIA IS DAR (J. Arriaga) come in sharply at the start, knocking #4 HAWKINS JET (D. Boag) off stride.

The second incident involved second place finisher #2 MYRNAS JAZZ (M. Rodriguez) and #1 CHECKTHISMEMO, who finished sixth. In this incident the #2 horse came in and bumped #1, causing him to steady sharply.

In both incidents the stewards felt that the impeded horses' chances of a better placing were compromised and the offending horses were disqualified. In the first incident #5 was disqualified from fourth and placed fifth. In the second incident #2 was disqualified from second and placed sixth.

10-01-08⁸ **JOCKEY OBJECTION – NO CHANGE – Seventh Race**

Following the running of the seventh race the rider of third place finisher, #6 EASTER HIGH (Macario Rodriguez), claimed a foul against the winner, #9 TIME CAT (Modesto Linares), for alleged interference going into the 3/8 turn. After reviewing the tapes and talking to the patrol judge the objection was dismissed and the race was declared official.

10-01-08⁹ **RIDER EXCUSED**

The track physician called the stewards to report jockey Edgar Montehermoso appeared weak and tired resulting from a combination of the heat and reducing and recommended he be excused from his remaining three mounts.

10-01-08¹⁰ **INQUIRY – NO CHANGE – Ninth Race**

The inquiry sign was posted for an incident involving the start of race ten. When the field was dispatched by the starter #6 THE ROYAL PAIR failed to break with the field. A review of the tapes show that just before the gates open #6 started to rear up. The assistant starter handling him tried to restrain him and at the same instant the jockey stepped off and the starter sent the field on its way. It was a case of the horse causing its own problem. No action was warranted. The horse was declared a starter and the race was declared official.

10-02-08¹ **SCRATCH TIME**

Scratch time for Saturday was conducted at 9:00 a.m. and consisted of two scratches and five rider changes.

10-02-08² **FILM REVIEW**

Jockeys **Macario Rodriguez** and **Jesus Arriaga** came in as requested to review their rides in yesterday's second race. Jesus rode #5 SOFIA IS DARK who was disqualified for coming in sharply at the start. On the films you can see Jesus' right arm come out when he pulled on the rein which showed he was making an effort to straighten his mount. Because of that effort Jesus was given a warning following a 2 to 1 vote with Nicolo dissenting. It was explained to Jesus by Steward Nicolo the reason for his dissenting vote was because he expected to see the horse's head turn, not just the movement of taking a hold of the rein.

Macario rode the #2 horse in the second race and was disqualified for bothering the horse on his inside. The films show after bumping the horse inside of him he straightened his horse then, unfortunately, he hit him again right handed which caused his horse to come in and bump the other horse again. Macario offered no excuse and knew better than to waste a good story on a bad ride.

10-02-08³ **WEIGHT ISSUE**

Clerk of Scales **Cheryl White** called the stewards to inform them that jockey **CARLOS VILLALOBOS** could not make weight and replacement riders were needed in the first and third races. Carlos was instructed to see us in the morning.

10-02-08⁴ **RULING NO. 1 – KELLER**

Trainer **FRANKLIN V. KELLER** is fined the sum of three hundred dollars (\$300.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for improperly medicating APRIL'S WAY after entry, necessitating the late declaration from the seventh race on Thursday, October 2, 2008 at Big Fresno Fair.

The above ruling was issued after Mr. Keller and Fitness Veterinarian Don Dooley came in and informed the stewards that the horse APRIL'S WAY was inadvertently treated after it had been entered.

10-02-08⁵ **RULING NO. 2 – KASPARIAN**

Jockey Agent **DAVE KASPARIAN** is fined the sum of fifty dollars (\$50.00) pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations) for failure to conduct his business in the proper manner on Wednesday, October 1, 2008.

The above ruling was issued after Dave took responsibility for a miscommunication with his rider necessitating a late rider change.

10-02-08⁶ **RULING NO. 3 – RODRIGUEZ**

Jockey **MACARIO RODRIGUEZ**, who rode **MYRNAS JAZZ** in the second race at the Big Fresno Fair on Wednesday, October 1, 2008, is suspended three (3) racing days (October 9, 10 and 11, 2008) for failure to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to sixth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

After reviewing Wednesday's second race with the stewards the foregoing ruling was issued.

10-02-08⁷ **RULING NO. 4 – RIESGO**

Trainer **ART RIESGO** is fined the sum of two hundred dollars (\$200.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to deliver the horse YUGOTMECONFUSED to the receiving barn, necessitating a late declaration from the fourth race on Wednesday, October 1, 2008; a violation of California Horse Racing Board rule #1852 (Reporting to Receiving Barn).

The above ruling was issued following a phone conversation with Art who could offer no acceptable excuse for not having his horse at the receiving barn at the scheduled time.

10-03-08⁴ **FILM REVIEW**

KEVIN ROSE watched the tapes of Thursday's seventh race with the stewards. The films show that as the horses are going into the turn Kevin, on the outside, comes in causing the rider inside of him to clip his heels while steadying. Kevin thought he was running by the other horse fast enough to clear him without bothering him; however, the tape shows otherwise. After a short deliberation the following ruling was issued.

RULING NO. 5

Jockey **KEVIN ROSE**, who rode **VALID'S RED ROSE** in the seventh race at the Big Fresno Fair on Thursday, October 2, 2008, is suspended three (3) racing days (October 10, 11 and 12, 2008) for altering course without sufficient clearance and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

An inquiry into the running of the fifth race resulted in the disqualification of third place finisher #6 ANGELO'S LUCK (J. Ayarza). The films show #6 drifting out and repeatedly bumping #7 MR. BETH (D. Boag). The resulting chain reaction compromised both #7, who finished fifth and #8 DARK WING (J. Gomez), who finished sixth, a chance at a better placing. In a unanimous decision, #6 was disqualified from third and placed sixth.

The X-7 on the overnight for Cal-Bred maidens was called off with three entries.

10-04-08² **SCRATCHES and CHANGES**

Two scratches and twelve rider changes were made at scratch time.

10-04-08³ **FILM REVIEW**

Jorge Ayarza went over yesterday's third race in which his mount, #6 TRULY RULEY, was disqualified for drifting out through the stretch. Jorge stated he was avoiding the heels of the horse in front of him. The horse he was following was drifting but it was questionable whether Jorge was within danger of clipping heels. We explained regardless of his quandary it did not give him the right to push horses out of his way. After a brief deliberation, Jorge was given a pass with a warning that showing more patience and better judgment will avoid visits to our office and possible days in the future.

10-04-08⁴ **GONZALEZ HEARING**

Trainer **MIGUEL GONZALEZ** requested an informal hearing, accepting responsibility for the positive findings in California Horse Racing Board complaints 08GG132 and 08SW-0092.

On complaint 08GG132, the horse FIXINTODASH, who ran first in the first race at the San Mateo County Fair on August 9, 2008, tested positive for Dextrorphan, a prohibited Class IV drug. In this case Mr. Gonzalez said (just when you thought you have heard it all) his horse was coughing so he had been giving his horse Nyquil. I will spare you the

details of the lecture that followed that admission.

On complaint 08SW-0092, the official test sample taken from BONOS CHARGER, who finished first in the third race at Cal-Expo State Fair on August 24, 2008, contained 4-Methylaminoantipyrine, a metabolite of Dipyrone. Mr. Gonzalez stated that he had no idea what Dipyrone was or how it got into his horse's system. Dr. Arthur was consulted on this matter since Dipyrone is not a FDA approved drug. Decision forthcoming.

10-04-08⁵ **TOWELL HEARING**

BRUCE TOWELL waived his right to a formal hearing and met informally with the stewards to address CHRB complaint 08SW-0093. The violations in the complaint were rules 1874 (Disorderly Conduct) and 1902 (Conduct Detrimental to Horse Racing). Bruce had a painfully long explanation but he did sign off on the complaint. A ruling is forthcoming.

10-04-08⁶ **NEW TRACK RECORD – Second Race**

GENIE-JONES ran off and won as she pleased the crowd while setting a new track record of 23.06 for 400 yards.

10-04-08⁷ **JOCKEY OBJECTION – NO CHANGE – Fourth Race**

Following the running of the fourth race **Jorge Ayarza**, who rode #1 NATIONWIDE FAMILY who finished fifth, claimed a foul against **Modesto Linares**, who rode #2 SGT. TUNER, for allegedly hitting him with his whip. On the films you can see Modesto hit Jorge and he appeared to be talking to him when he ran up beside him. The incident did not warrant a disqualification but it will be addressed in the morning.

Jesus Arriaga was called in for hitting his mount in the head in yesterday's third race. Jesus was informed that this is indefensible and would not be tolerated. The following ruling was issued:

RULING NO. 6 – ARRIAGA

Jockey **JESUS ARRIAGA** is fined the sum of three hundred dollars (\$300.00) for violation of California Horse Racing Board rule #1688 (Use of Whips) during the running of the third race on Saturday, October 4, 2008.

Carlos Villalobos was called in for failing to make weight on Thursday and not showing up to ride on Friday. Carlos gave no acceptable excuse for either offense. After a short deliberation the following rulings were issued:

RULING NO. 7 – VILLALOBOS

Jockey **CARLOS VILLALOBOS** is hereby fined the sum of one hundred dollars (\$100.00) for failure to fulfill his riding engagements at the Big Fresno Fair on Thursday, October 2, 2008; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

RULING NO. 8 – VILLALOBOS

Jockey **CARLOS VILLALOBOS** is fined the sum of one hundred dollars (\$100.00) pursuant to California Horse Racing Board rule #1683 (Maximum Overweight) for failure to make weight on his mounts on Thursday, October 2, 2008, necessitating late rider changes.

Modesto was called in for two incidents. Modesto failed to get to the jockey's room in time to ride the first race. He said he over slept. We will issue a wake up call later.

In Saturday's fourth race, Jorge Ayarza claimed a foul against Modesto for hitting him with the whip. The film confirmed the allegation and Modesto did not deny it. He said he let his temper get the best of him. He knew what he did is unacceptable but stated he has had several run-ins with Jorge and he just lost it. We will help him find it. The following rulings were issued:

RULING NO. 9 – LINARES

Jockey **MODESTO LINARES** is hereby fined the sum of one hundred dollars (\$100.00) for failure to fulfill his riding engagement in the first race at the Big Fresno Fair on Saturday, October 4, 2008; a violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

RULING NO. 10 – LINARES

Jockey **MODESTO LINARES** is fined the sum of five hundred dollars (\$500.00) for striking another jockey with a whip during the running of the fourth race on Saturday, October 4, 2008; a violation of California Horse Racing Board rule #1699 (e) (Riding Rules).
