STATEMENT OF CHANGES WITHOUT REGULATORY EFFECT

Pursuant to Title 1, Section 100, Subdivision (b)(1), of the California Code of Regulations, the California Horse Racing Board (CHRB) hereby submits this written statement explaining why the proposed amendments to section 1596 of Article 6 and section 2057 of Article 24, Title 4, Division 4 of the California Code of Regulations (CCR) do not materially alter any requirement, right, responsibility, condition, prescription, or other regulatory elements of any CCR provision.

Subject to the approval of OAL, the CHRB would revise text published in the California Code of Regulations as follows:

I. Section 1596 (Transfer After Sale of Horse on the Grounds)

In paragraph one, correct the version date of CHRB Form-101 from “3/97” to “10/22”

CHRB Form-101 was reformatted and made fillable in 2022 without making the associated change to the form’s version date in regulation. This change corrects the reference to reflect the most current CHRB Form-101 and serves to provide necessary clarification. No content of the form was changed and the correction is a permissible change without regulatory effect pursuant to Section 100, Subdivision (a)(4) of California Code of Regulations.

II. Section 2057

In subsection (12)(g), correct the version date of Form CHRB-25 from “10/23” to “1/23”

The reference to version date “10/23” for form CHRB-25 in section (12)(g) was incorrectly updated when this section was amended, effective January 1, 2025. The version of the form is correctly referenced in subdivision (a) of Rule 2056. The change to subsection (12)(g) corrects a reference error and serves to provide necessary clarification and is specifically listed as a permissible

change without regulatory effect in section 100, Subdivision (a)(4) of California Code of Regulations.

III. Form CHRB-25A

Update the version date of Form CHRB-25A from 10/23 to 04/23.

The version date on the CHRB-25A form was incorrectly updated when this section was amended, effective January 1, 2025. The change corrects the error on the form to update it from 10/23 to 04/23 and serves to provide necessary clarification and is specifically listed as a permissible change without regulatory effect in section 100, Subdivision (a)(4) of California Code of Regulations. Form CHRB-25A is referenced in CHRB Rules 1433, 2057, and 2066.

The proposed amendments would make necessary changes to correct references to CHRB forms. The changes being proposed do not materially alter any requirement, right, responsibility, condition, prescription, or other regulatory element of any California Code of Regulations provision.
